WHEREAS, from 1996-98, K.C. Williams served as the School Media Specialist/Technology Librarian for Ocean Springs High School in Ocean Springs, Mississippi, before becoming the Library Director at Mississippi Gulf Coast Community College in Jackson County, Gautler, Mississippi, the position in which she served until 2000; and

WHEREAS, from 2000-03, she served as the Technology Program Coordinator/Trainer for the Gulf Coast Education Initiative Consortium at the University of Southern Mississippi Gulf Park Campus in Long Beach, Mississippi; and

WHEREAS, since 2003, Ms. Williams has served estimably as the System Director of the Sevier County Public Library System, the position from which she is resigning; and

WHEREAS, during her laudable career with Sevier County, K.C.
