Franks, during which time she paid her own way through law school; was a law clerk for the U.S. Bankruptcy Trustee; and worked in private practice; and

WHEREAS, respected and admired by her peers within the legal community, Vanessa Bryan served as a hearing officer for the Tennessee Board of Professional Responsibility, a member of the board of directors of the 21st Judicial District Drug Court and the D.U.I. Drug Court, and Barrister and Master of the Inns of Court, John Marshall Chapter; and

WHEREAS, she is a member of the Williamson County Bar Association, the Tri-County Bar Association, the Tennessee Association of Criminal Defense Lawyers, Williamson County Republican Career Women, Leadership Franklin, Daughters of the American Revolution, Girl Scouts of America, the League of Women Voters, and the Yellow Rose Society Suffragette Memorial; and

WHEREAS, Mrs. Bryan has lent her time and talents to a number of educational, community, and charitable organizations, including the Nashville Rescue Mission, Women Are Safe of Centerville, the Literacy Council of Williamson County, Elam Center of Meharry Hospital, Belmont School of Law, Vanderbilt Law School, Nashville Auto Diesel College, University of Tennessee Law School, Nashville School of Law, Mending Hearts, Discovery House, Buffalo Valley, New Life Lodge, Mercy Clinic, Refuge Center, and Magdellan House; and

WHEREAS, devoted to her family, Vanessa Bryan enjoys the love and support of her husband, Oval Nelson Bryan III, and their children, Zachary Taylor Bryan and Joseph MacRae Bryan; and
