leadership; he subsequently earned a Doctor of Ministry degree in Transformative Leadership from the Colgate Rochester Crozer Divinity School in Rochester, New York; and

WHEREAS, throughout his years of astute leadership, Dr. Turner demonstrated his talents in several positions; he served as president of the Yale Divinity School student council, vice president of the Connecticut State Missionary Baptist Convention, chairman of the board of commissioners of the Housing Authority for New Haven, and secretary of the board of directors of the National Action Network. Additionally, he is the proud founder and president of the Black Clergy Collaborative of Memphis; and

WHEREAS, Reverend Dr. J. Lawrence Turner continues to demonstrate excellence in his calling as a man of God; the members of his congregation are proud to call him their pastor, leader, and friend and look forward to his continued spiritual guidance for many years to come; now, therefore,
