WHEREAS, his vast influence on the City of Franklin includes his work on the current streetscape, planned during his tenure as president of the Downtown Franklin Association, which has become a beautiful, brick-lined retail attraction; and WHEREAS, Mr. Peach enjoyed the loving companionship of his wife of fifty-nine years, Emily Peach, and was the proud father of Rebecca (Larry) Piggott, Lucie (Danny) Logan, and Dea Peach; loving grandfather of Addison (Ellen) Clayton, Shelby Piggott, Emme Logan, Brant Piggott, Maddie Logan, Ford Logan, and Athena Peach; and doting great-grandfather of Strick Clayton; and

WHEREAS, he will be sadly mourned but fondly remembered by his sister, Burnetta Gary, and a host of extended family members, dear friends, former customers, and all those whose lives he touched in the Franklin community; and

WHEREAS, Bill Peach leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and
