WHEREAS, no stranger to accolades for her exemplary public service and potent advocacy, Mrs. Acey has been recognized by the *Tri-State Defender* as a Pioneer; Alpha Kappa Alpha Sorority, Inc., as Beta Epsilon Omega Soror of the Year, Southeastern Regional Humanitarian Soror of the Year, and International World Community Soror; and The National Sorority of Phi Delta Kappa, Inc., as Outstanding Soror of the Year and Southeastern Regional Honoree. Anthony Award, and the Center City Commission's Vision honor for Africa In April, among others; and
