WHEREAS, he enjoyed a lively personal life, partaking in numerous hobbies with friends and family over the years; he was a master gardener and gourmet cook as well as a certified

scuba diver, and some of his greatest joys were sailing in the Caribbean for sixteen years, traveling to Europe, hunting, and water-skiing; and

WHEREAS, devoted to his faith, Mr. Fish was a longtime member of Otter Creek Church of Christ in Brentwood; and

WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Mr. Fish enjoyed the loving companionship of his wife, Lydia Lee Cox, and was the proud father of Suzanne Fish (Tate) Thigpen and the devoted grandfather of Kathleen; and
