WHEREAS, scenes from the film *Sweet Dreams*, the life story of Patsy Cline, were filmed in front of Pastime in 1985; and

WHEREAS, the pool hall has three tables that are approaching the century mark, including two snooker tables and a nine-ball table, and a patron can play pool the entire day for a mere ten dollars; and

WHEREAS, in 1996, Toni Lester and her late husband, Jimmy Lester, bought Pastime from Kyle Matthews, who was only willing to sell the business to a barber; and

WHEREAS, nearly twenty-eight years later, Pastime continues as a family business, as Mrs. Lester's daughter, Paige Bailey, has worked alongside her mother for the past fourteen years, and the other five barbers are treated like family members, even though they may not be related by blood; and

WHEREAS, noted for its quality service, Pastime offers haircuts for only twenty-five dollars, including a free hot-towel neck shave and a free game of pool, a true bargain in these inflationary times; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRTEENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we honor and recognize owner Toni Lester and the other barbers at Pastime Barber Shop and Pool Hall on the occasion of the establishment's 120th anniversary and extend to them our best wishes for another 120 years of operation.
