A RESOLUTION recognizing Pastor Leonard Dawson.

WHEREAS, he is also a member of a number of community and civic organizations, including the NAACP and Life Memphis of SCLC; and

WHEREAS, a devoted family man, Pastor Dawson is perhaps proudest of the love and support he shares with his wife, Mary Jane Dawson, his two children, and his five grandchildren; and

WHEREAS, Pastor Leonard Dawson is an upstanding member of his church and his community, and it is wholly fitting that he be recognized for his stalwart service to the Lord; now, therefore,
