WHEREAS, after his active-duty service, he continued serving his country in the reserves, flying the C-124 Globemaster, the C-7 Caribou, and the C-130 Hercules before retiring in 1985 as a lieutenant colonel following twenty-one years of service; and

WHEREAS, his career in flight spanned nearly forty years, with more than 18,000 hours flying fighters, airliners, helicopters, and transports before his official retirement in 2003; and

WHEREAS, after his retirement, he enjoyed birdwatching from his back porch and spending time with his children and grandchildren; and

WHEREAS, a devout and faithful man, Mr. Poe was an active member of Ooltewah Baptist Church; and

WHEREAS, he was also deeply devoted to his family and always endeavored to remain true to family values of the highest order; and

WHEREAS, Arthur Key Poe II will be mourned yet fondly remembered by his children, Key (Tracey) Poe, Marie Poe Mossbeck, Amelia Poe, and Nicholas (Briana) Poe; his four grandchildren, Abigail Poe, Samuel Mossbeck, Andrew Mossbeck, and Margaret Poe; and a host of extended family members and friends; and

WHEREAS, in addition to his parents, he was preceded in death by his beloved wife of forty-five years, Margaret Guille Poe; his brother, Toy Lee Poe; and his granddaughter, Sara Margaret Hoover; and
