WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Paul Elton Bass; and

WHEREAS, Mr. Bass was a veteran of the United States Air Force and a beloved educator who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born on January 6, 1956, Paul Bass was the son of Addie Sue Bass; he confessed his love for Christ at an early age and was baptized at Galilee Baptist Church, where he was a member of the junior choir; he was also a member of the chorus at Pearl High School, from which he graduated in 1973; and

WHEREAS, Mr. Bass attended Tennessee State University (TSU), where he was a member of the Air Force ROTC "Tiger Jets" drill team, Meister Singers, and Youth Mentoring; following a stint at TSU, he enlisted in the U.S. Air Force, serving his country under the rank of Medical Service Specialist, E4; and

WHEREAS, upon returning to civilian life, Paul Bass enrolled at Middle Tennessee State University, where he was a member of the Kappa Xi Chapter of Alpha Phi Alpha Fraternity, Inc.; after a year there, he returned to TSU, from which he earned his bachelor's degree; and

WHEREAS, after graduation, Mr. Bass embarked upon his forty-year teaching career, serving as the in-school suspension counselor at Bass Middle School; then, in 1989, he joined the faculty at Martin Luther King Jr. Magnet High School, where he was beloved by all who walked its halls and had a profound, lasting impact on his students and colleagues; and

WHEREAS, during his twenty-five-year tenure at Martin Luther King Jr. Magnet High School, Paul Bass taught science and coached wrestling and soccer; although he retired in 2014, he returned to Metro Nashville Public Schools in 2015 as a part-time employee at Martin Luther King and The Academy at Old Cockrill; and

WHEREAS, highly regarded by those in his field, Mr. Bass was named Teacher of the Year on multiple occasions and was recognized by the National Wrestling Coaches Association; he was a member of the Tennessee Education Association and the Metropolitan Nashville Education Association and received service awards from the Big Brothers Big Sisters organization; and

WHEREAS, in addition to his devotion to his students, Paul Bass was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and
