WHEREAS, Trooper Stanford is renowned for his ability to recognize opportunity and seize the initiative and is especially adept at handling the very dangerous situations he and his fellow police officers encounter on a regular basis; and

WHEREAS, in 2008, Dwayne Stanford was instrumental in the apprehending of an armed robber and the suspect's extradition back to Mississippi; and

WHEREAS, in 2009, Trooper Stanford garnered a total of thirty-three DUI arrests and twenty-three felony arrests, and issued 1,305 citations; also that year, he assisted in searching for and locating a missing five-year-old girl who had wandered away from her home in Gibson County; and

WHEREAS, thus far in 2010, Trooper Stanford's activity has included twenty-six arrests, six DUIs, two felony DUIs, five felony drug arrests, one captured fugitive, and 295 citations; and

WHEREAS, in January of this year, he assisted in locating and apprehending a wanted felony suspect; the following February, he located a kidnapped juvenile female victim from the state of Maryland, and in March, he located a felony fugitive suspect in Decatur County who was wanted by the FBI; and

WHEREAS, one of the most trusted, reliable, and focused officers on the Tennessee

Highway Patrol, Trooper Stanford has served with the utmost integrity and professionalism,

earning the respect and admiration of his peers, superiors, and the citizens he nobly serves for
the exemplary quality of his work; and

WHEREAS, an instinctive leader with the ability to generate confidence in his fellow officers, Trooper Dwayne Stanford has contributed greatly to the safety of his fellow citizens, responding to every call with tremendous courage, fortitude, and professionalism, making a significant impact for the better on his community; and
