WHEREAS, NHC Dickson received the Silver National Quality Award from the American Health Care Association and National Center for Assisted Living in 2023; it has also been a finalist for and won numerous NHC Honor Club and Legends Awards in previous years; and

WHEREAS, Mr. Vincent's receipt of the NHC Administrator of the Year honor comes after his being a finalist for three of the past five years, a testament to the consistency of his excellence and dedication; and

WHEREAS, throughout his many successes, Brandon Vincent has enjoyed the love and support of his wife, Kelly; they are the proud parents of three children, Hayden, Austin, and Beau; and

WHEREAS, Mr. Vincent has proven himself a leader in his profession, and the patients and partners of NHC Dickson have benefited greatly from his guidance and service; now, therefore,
