WHEREAS, it was with great sadness that we learned of the untimely passing of our esteemed colleague Representative Bill Beck of Nashville; and

WHEREAS, known affectionately as the "Prince of Madison," Representative Beck distinguished himself as a public-spirited citizen of the highest order and as an exceptional asset to the good people of the 51st House District, whom he served as a member of the 109th, 110th, 111th, 112th, and 113th General Assemblies; and

WHEREAS, born on March 21, 1962, Carson W. "Bill" Beck received his Bachelor of Science degree in Business Administration from Belmont University and his Juris Doctorate from Nashville School of Law; for thirty-three years, he practiced law with his family firm, Beck & Beck Attorneys at Law, earning the respect of the courthouse and those of the Madison suburb where he grew up; and

WHEREAS, Representative Beck was an active and dynamic participant in the legislative process throughout his time in the General Assembly; his remarkable record included service as the Democratic Caucus Floor Leader and a member of the Civil Justice Committee; State Government Committee; Transportation Committee; Ethics Committee; Select Ethics Committee; Judiciary Committee; State Committee; Naming, Designating & Private Acts Committee; Joint Fiscal Review Committee; Insurance and Banking Committee; Civil Justice Subcommittee; Departments & Agencies Subcommittee; Workplace and Harassment Subcommittee; Criminal Justice Subcommittee; and Select Ethics Subcommittee; and

WHEREAS, he also served as a member of the Calendar and Rules Committee of the Second Extraordinary Session and the Judiciary Committee of the Third Extraordinary Session during the 112th General Assembly and a member of the Public Safety Committee of Extraordinary Session II of the 111th General Assembly; and

WHEREAS, during his tenure in the General Assembly, Representative Beck worked diligently to pass several bills, including ones that expanded maternity and paternity leave for state employees and ensured that homeless students obtain a birth certificate and a photo identification; his success was attributable to his ability to work not only with those in his party, but also those across the aisle; and

WHEREAS, he also gave back to his community through his involvement with and contributions to the Kiwanis Club of Madison, Inglewood Homeowner's Association, American Legion Post 82, Old Hickory Chamber of Commerce, Madison Chamber of Commerce, Discover Madison, Inc., Historic East Nashville Merchants Association, and Allegro School of Music, which he served as a member of the Board of Directors; and

WHEREAS, a member and fellow of the Nashville Bar Association, Representative Beck was honored by Fifty Forward Madison with the Best Problem Solver Award and received recognition in civil engineering from the Air National Guard; and

WHEREAS, deeply devoted to his family, Representative Bill Beck will be sadly mourned but fondly remembered by his beloved wife, Pamela Beck; daughter, Meredith (Andy) Costello; mother, Martha Lucinda Cone Beck; brother, Robert B.
