AN ACT to amend Tennessee Code Annotated, Title 48 and Title 61, relative to business organizations.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 48-11-301(d), is amended by deleting the language "or legal".

SECTION 2. Tennessee Code Annotated, Section 48-11-301(I), is amended by inserting the language "or other electronic means" between the language "transmission" and the punctuation ".".

SECTION 3. Tennessee Code Annotated, Section 48-12-102(a), is amended by inserting the following language as a new subdivision (6) and renumbering subsequent subdivisions accordingly:

(6) A contact number or email address;

SECTION 4. Tennessee Code Annotated, Section 48-25-103(a), is amended by inserting the following language as a new subdivision (6) and renumbering subsequent subdivisions accordingly:

(6) A contact number or email address;

SECTION 5. Tennessee Code Annotated, Section 48-26-203(a), is amended by inserting the following language as a new subdivision (4) and renumbering subsequent subdivisions accordingly:

(4) A contact number or email address;

SECTION 9. Tennessee Code Annotated, Section 48-52-102(a), is further amended by inserting the following language as a new, appropriately designated subdivision:

() A contact number or email address;

SECTION 10. Tennessee Code Annotated, Section 48-65-103(a), is amended by deleting subdivision (7) in its entirety and by substituting instead the following language:

- (7) One of the following statements:
 - (A) The corporation will not have members; or
- (B) The number of members of the corporation on the filing date of the charter:

SECTION 15. Tennessee Code Annotated, Section 48-247-101(d), is amended by deleting the language "or legal".

SECTION 16. Tennessee Code Annotated, Section 48-249-202(a)(5), is amended by deleting subdivision (5) in its entirety and by substituting instead the following language:

- (5) A statement of the number of members at the date of the filing of the articles;
- SECTION 17. Tennessee Code Annotated, Section 48-249-202(a), is amended by inserting the following language as a new, appropriately designated subdivision:

SECTION 18. Tennessee Code Annotated, Section 48-249-904(a), is amended by deleting subdivision (6) in its entirety and by substituting instead the following language:

(6) The number of members of the LLC at the date of filing the application for the certificate of authority.

SECTION 19. Tennessee Code Annotated, Section 48-249-1005(d), is amended by deleting the language "or legal".

SECTION 20. Tennessee Code Annotated, Section 48-249-1017(a)(6), is amended by deleting the language ", or if such number has not been obtained, a representation that it has been applied for".

SECTION 21. Tennessee Code Annotated, Section 48-249-1017(a), is amended by deleting subdivision (7) in its entirety and by substituting instead the following:

(7) The number of members of the LLC at the date the annual report is executed on behalf of the domestic or foreign LLC.

SECTION 22. Tennessee Code Annotated, Section 61-1-105(a), is amended by redesignating subsection (a) as subdivision (a)(1) and by adding the following language as a new subdivision (2):

(2) The secretary of state has the power to promulgate appropriate rules and regulations establishing acceptable methods for execution for any document to be filed with the secretary of state.

SECTION 23. Tennessee Code Annotated, Section 61-1-1001(a), is amended by inserting the language "a contact number or email address;" between the language "maintain;" and the language "a brief statement" and redesignating subsection (a) as subdivision (a)(1).

SECTION 24. Tennessee Code Annotated, Section 61-1-1001(a), is amended by adding the following language as a new subdivision (2):

(2) The secretary of state has the power to promulgate appropriate rules and regulations establishing acceptable methods of execution for any document to be filed with the secretary of state.

SECTION 25. Tennessee Code Annotated, Section 61-1-1001(f)(2), is amended by deleting the language "period." and substituting instead the language "period, or that the partnership submitted to the secretary of state a check, bank draft, money order or other such instrument for payment of a fee and the instrument was dishonored upon presentation for payment."

SECTION 26. Tennessee Code Annotated, Section 61-1-1004(d), is amended by inserting the following language as a new, appropriately designated subdivision:

() A contact number or email address;

 SECTION 27. Tennessee Code Annotated, Section 61-2-201(a), is amended by inserting the following language as a new, appropriately designated subdivision:

() A contact number or email address;

SECTION 28. Tennessee Code Annotated, Section 61-2-902(a)(1), is amended by inserting the following language as a new, appropriately designated subdivision:

() A contact number or email address;

SECTION 29. Tennessee Code Annotated, Section 61-2-1101(d), is amended by deleting the language "or legal".

SECTION 30. Tennessee Code Annotated, Section 61-2-1102, is amended by deleting the language "but" and by substituting instead the language "and" and by deleting the language "not".

SECTION 31. This act shall take effect on July 1, 2011, the public welfare requiring it.
