AN ACT to amend Tennessee Code Annotated, Title 71, Chapter 5, Part 10, relative to the nursing home assessment.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 71-5-1002(h)(1), is amended by deleting the language "FY 2021-2022" and substituting instead the language "FY 2022-2023".

SECTION 2. Tennessee Code Annotated, Section 71-5-1003(c), is amended by deleting the first sentence, which presently reads:

The total aggregated amount of assessments for all nursing facilities from July 1, 2021, through June 30, 2022, is equal to four and three-quarters percent (4.75%) of the net patient service revenue.

and substituting instead the following:

The total aggregated amount of assessments for all nursing facilities from July 1, 2022, through June 30, 2023, is equal to four and three-quarters percent (4.75%) of the net patient service revenue.

SECTION 3. Tennessee Code Annotated, Section 71-5-1003(c)(1), is amended by deleting the language "July 1, 2021" and substituting instead the language "July 1, 2022".

SECTION 4. Tennessee Code Annotated, Section 71-5-1003(c)(2), is amended by deleting the language "July 1, 2021" and substituting instead the language "July 1, 2022".

SECTION 5. Tennessee Code Annotated, Section 71-5-1003(c)(3), is amended by deleting the language "July 1, 2021" and substituting instead the language "July 1, 2022".

SECTION 6. Tennessee Code Annotated, Section 71-5-1003(c)(4), is amended by deleting the language "after July 1, 2021, shall pay in FY 2021-2022" and substituting instead the language "after July 1, 2022, shall pay in FY 2022-2023".

SECTION 7. Tennessee Code Annotated, Section 71-5-1003(c)(5), is amended by deleting the language "from July 1, 2021, through June 30, 2022" and substituting instead the language "from July 1, 2022, through June 30, 2023".

SECTION 8. Tennessee Code Annotated, Section 71-5-1010(a), is amended by deleting the language "June 30, 2022" and substituting instead the language "June 30, 2023".

SECTION 9. This act takes effect July 1, 2022, the public welfare requiring it.
