umpired summer youth league baseball and softball for many years, and he served as a

nonfaculty assistant coach for three years alongside his daughter Katelyn, who was head softball coach at East Robertson Middle School; and

WHEREAS, in addition to being a proponent of youth sports, Jerry Duncan was a mentor and advocate for many young people in his community; he and his wife opened their home to their children's school friends and youth group, providing a safe environment in which they would play games, eat meals, share their problems, and have devotionals; and

WHEREAS, in keeping with his compassionate calling to help young people, Mr. Duncan was active with Open Door Pregnancy Center and TNKids Nutrition, serving on the board of both organizations; and

WHEREAS, for the past six years, Mr. Duncan had been a valued member of Main Street Church of Christ, serving as an elder and a beloved mentor to many; and

WHEREAS, Jerry Duncan is survived by his wife, Lisa; his son, Hunter Duncan, and Hunter's fiancé, Andrea Smith; his honorary son, Christopher Zubrod; his daughters, Katelyn (Seth) Doxey and Holli (Derek) Moore; and his granddaughter, Brooklynn Moore, who brought immense joy to his life during the brief four months they crossed paths in this world; and
