WHEREAS, no stranger to awards and accolades, Commissioner Hommrich received the Commissioner's Award from the Administration of Children, Youth, and Families in 2012; and

WHEREAS, Commissioner Bonnie Hommrich is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and she should be specially recognized; now, therefore,
