WHEREAS, interested in history and relics of the past, Mr. Ross devoted considerable effort over the span of fifteen years to the construction of several log structures at his home in Maryville, assembling them from the viable remnants of older log buildings; and

WHEREAS, turning his industriousness and skills as a carpenter to helping those in need, he contributed his time and energy to Habitat for Humanity, the Appalachian Service Project, and the people of the Dominican Republic; and

WHEREAS, deeply devoted as well to his family, Dale Ross always endeavored to remain true to family values of the highest order; and

WHEREAS, Mr. Ross enjoyed the loving companionship of his wife of fifty years, Pat, and was the proud father of Laura Ross Lyman, Julia Ross, Leanne Ross Farash, Susan Ross Jenkins, Rebecca Jordan, Jeff Ross, and Jon Ross; and
