## **SENATE JOINT RESOLUTION 77**

A RESOLUTION to confirm the appointment of Julie Schuster to the Tennessee fish and wildlife commission.

WHEREAS, Tennessee Code Annotated, Section 70-1-201, as amended by Chapter 993 of the Public Acts of 2012, provides for the creation of the Tennessee fish and wildlife commission; and

WHEREAS, a person of many talents, she served with distinction as promotions/marketing manager at the Nashville location of the nation's largest outdoor supplier,

Bass Pro Shops, for nine years, and she has coordinated the Gaylord Hotel and Resort Center Land and Wildlife Expo each of the past two years; and

WHEREAS, Mrs. Schuster is fortunate to share love and companionship with her husband, Darrell; and

WHEREAS, Mrs. Schuster's experience and dedication to wildlife and conservation issues would be a tremendous asset to the Tennessee fish and wildlife commission; and

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED EIGHTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of Julie Schuster of Cheatham County to a two-year, eight-month term on the Tennessee fish and wildlife commission, such term to expire on February 28, 2015.
