WHEREAS, in the mid- to late-1980s, Mr. Browder was a councilman of the City of Bolivar while concurrently serving as its police and fire commissioner; he was also a past chairman of the board for Merchants and Planters Bank, and he served his country bravely as a member of the United States Air Force; and

WHEREAS, a man of devout faith, Mr. Browder was an active member of Bolivar First Baptist Church; and

WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Art Browder was blessed with the love and companionship of his wife,
Rosalyn Sammons Browder; the two were married on July 9, 1967, and enjoyed fifty-three years
of marriage; and

WHEREAS, Mr. Browder is survived by his wife; his daughter, Ellen (Mark) Fulghum; his grandchildren, Becca (Josh) Jeter and Ben Fulghum; his sister-in-law, Doris Browder; and several nieces and nephews; and

WHEREAS, in addition to his parents, he was preceded in death by a sister and brother-in-law, Joyce and Karl Warren, and a brother, Buford Irwin Browder; and

WHEREAS, Art Browder leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and
