A RESOLUTION to honor and congratulate AARP for sixty years of meritorious service.

WHEREAS, AARP, as a nonprofit, non-partisan organization working to address the needs and quality of life for people 50+ and their families, is continuing the work of its founder, Dr. Ethel Percy Andrus, a retired educator who lives by the motto "to serve and not be served"; and

WHEREAS, the AARP Foundation Tax Aide services, delivered at more than sixty locations across Tennessee by the program's IRS-certified volunteers, who prepared and filed more than 21,000 tax returns in 2018, are available for all Tennesseans regardless of age, income, or membership status; and

WHEREAS, AARP is helping Tennesseans to shatter stereotypes about aging by encouraging people 50+ to pursue new careers and educational opportunities and turn their dreams into real possibilities and join the movement to disrupt aging; now, therefore,
