## SENATE JOINT RESOLUTION 498

A RESOLUTION to honor David A. North upon his exemplary tenure as chairman of the University of Memphis Board of Trustees.

WHEREAS, the members of this General Assembly take great pleasure in recognizing those outstanding civic-minded individuals who have contributed significantly to the public institutions that make their communities grow and prosper; and

WHEREAS, David A. North recently completed his two-year tenure as chairman of the University of Memphis (UM) Board of Trustees but will continue to serve as a board member until 2025; and

WHEREAS, the many improvements, initiatives, and projects undertaken during Mr.

North's tenure resulted in UM making *U.S. News & World Report*'s Tier 1 of American colleges and universities; and

WHEREAS, Mr. North previously served on the UM Board of Visitors and concurrently serves on the university's Foundation Board and the President's Innovation Board; and

WHEREAS, a thirty-two-year veteran of risk management services, David A. North is president and chief executive officer of Sedgwick, which he has transformed into the premier global provider of innovative business solutions in the areas of workers' compensation, disability and absence management, and property loss adjusting; and

WHEREAS, he has previously served on the board of the Workers Compensation

Research Institute and is past chairman of the board of the Integrated Benefits Institute; and

WHEREAS, he is a member of the Business Insurance Women to Watch Advisory
Board and serves as the director for The Institutes, the leading provider of professional
