WHEREAS, Mr. Googe has been a member of the North Jackson Church of Christ and the Jackson Area Chamber of Commerce; chairman of the Volunteer Advisory Board of the Department of Corrections in Madison County; vice president of the local Federation of Musicians; and block captain of the Skyview Estates Neighborhood Watch Program; and

WHEREAS, a talented musician, Mr. Googe is currently the timpanist for the Jackson Area Community Band and has volunteered his time and talents at the Casey Jones Museum and the Depot Museum on South Royal in Jackson; and

WHEREAS, devoted to his family, George Googe enjoys the love and support of his wife, Becky; their two children, Wendy and Charles; and their three grandchildren; and

WHEREAS, George Googe exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his estimable career, George Googe demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of members of the bar and bench and his community alike; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED TWELFTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we commend George Morton Googe on his honorable and astute service to the people of Tennessee as the District Public Defender for the 26th Judicial District and extend to him our heartfelt wishes for a happy and fulfilling retirement.
