A RESOLUTION to recognize and commend Frank P. "Rusty"
Cantwell, Jr., Hamblen County honoree of the
Ageless Hall of Fame.

WHEREAS, a Vietnam veteran who achieved the rank of First Lieutenant in the United States Army, Rusty Cantwell earned his bachelor's degree from Vanderbilt University and his

Juris Doctorate from the University of Tennessee School of Law; he practiced law for nearly four decades, from 1974-2012; and

WHEREAS, throughout his many accomplishments and selfless service to his community, Mr. Cantwell has enjoyed the love and support of his wife, Reenie Cantwell, and their three daughters and four grandchildren; and

WHEREAS, senior adults in Tennessee often set the bar for service in their communities, and it is most fitting that they be recognized; and

WHEREAS, Hamblen County's Rusty Cantwell is a public-spirited individual of the highest order who has devoted his life to serving his fellow citizens, and he is most worthy of our approbation; now, therefore,
