A RESOLUTION to honor and commend the Cystic Fibrosis
Foundation Tennessee Chapter's 2014 class of
Nashville's Top 30 Under 30.

WHEREAS, one such group of individuals is the thirty men and women who have been selected as the members of the Cystic Fibrosis Foundation Tennessee Chapter's 2014 class of Nashville's Top 30 Under 30; and

WHEREAS, the Cystic Fibrosis Foundation is the world's leader in the search for a cure for cystic fibrosis (CF) and a non-profit, donor-supported organization dedicated to attacking cystic fibrosis from every possible angle; and

WHEREAS, the Cystic Fibrosis Foundation has as its central tenets supporting the development of new drugs to fight the disease, improving the quality of life for those with CF, and, ultimately, discovering a cure; and

WHEREAS, the Tennessee Chapter of the Cystic Fibrosis Foundation is an outstanding arm of this important organization, going above and beyond the call of duty to extend a helping hand to Tennesseans with CF who are in need of assistance; and

WHEREAS, each year, the Tennessee Chapter selects thirty individuals for its annual class of Nashville's Top 30 Under 30, which recognizes business professionals throughout Middle Tennessee for their leadership qualities, volunteerism, and business endeavors; and

WHEREAS, an attorney with Loeb and Loeb, LLP, Brittany Schaffer earned her Bachelor of Arts degree, graduating *magna cum laude*, from Vanderbilt University before earning her Juris Doctor degree, also *magna cum laude*, from Samford University's Cumberland School of Law, where she served as the editor-in-chief of the *Cumberland Law Review*. A leader in her community, she holds leadership positions with the Antiques and Garden Show of Nashville, Society of Leaders in Development, the Tennessee Bar Association Sports and Entertainment Committee, the Wilson County Young Republicans, and the I'll Fly Away Foundation; and

WHEREAS, Chase Cowden, employed by Custom Packaging in Lebanon, is the third-generation contributor to this family-owned packaging business. After first working as a registered nurse in the pediatric burn unit of Riley Hospital for Children, Ms. Parker joined the staff of the Vanderbilt Children's Hospital, rendering sterling service as a member of the Pediatric Intensive Care Unit; and

WHEREAS, Rebecca Ozols is a third-year teacher for Metro Public Schools and sponsors the cheerleading squad, the Fellowship of Christian Athletes, the yearbook, and the talent show at her school. WHEREAS, Whitney Henry Kimerling is an associate attorney in the Nashville office of Lewis Thomason. Ms. Kimerling graduated from the Cumberland School of Law at Samford University, where she was a Caruthers Fellow. While in law school, she was awarded the Rodney M. Max Mediation Fellowship, earned several Scholar of Merit distinctions, and served as President of the Tennessee Student Bar Association. Whitney Kimerling earned an undergraduate degree in human and organizational development, *magna cum laude*, from Vanderbilt University, and she is admitted to practice in both Tennessee and Alabama; and
