A RESOLUTION to honor and congratulate Douglas Binford on the celebration of his eightieth birthday.

Weidman, and the two were married in 1966 and finished their degrees together; and

WHEREAS, Mr. Binford's outstanding performance at Kroger earned him the title of Store Manager, and he quickly achieved three promotions to higher volume stores before becoming the Division Merchandising Manager in Charleston, West Virginia, and later the Division Sales Promotion Manager in Memphis; and

WHEREAS, after moving between Ohio and Texas and spending over twenty-five years with Kroger, Mr. Binford accepted the Vice President position with Red Food Stores in Chattanooga; following the purchase of Red Food Stores by BiLo Food Stores, Mr. Binford worked with National Convenient Stores and Diamond Shamrock before serving as a consultant with Pueblo Supermarkets in Puerto Rico and later helping with an expansion project for Pharmore Drug Stores; and

WHEREAS, in 2000, Mr. Binford returned to San Antonio, Texas, and purchased a decoration store with his wife, managing the establishment for ten years before retiring to Franklin, Tennessee, to be close to his daughter, Margaret, and grandchildren; and

WHEREAS, Mr. Binford's beloved wife Randall passed away on July 5, 2017, and two years later, he found love again when he met Mary Rebecca "Becky" Logsdon, whom he married on September 11, 2021; and

WHEREAS, as Mr. Binford enters his ninth decade, he is an active and productive member of the Ashton Park community in Franklin, who is admired for his wisdom, guidance, and generosity; and
