WHEREAS, a native of Virginia, Mrs. Brown received a bachelor's degree from Emory and Henry College and a master's degree in education-psychology and counseling from Virginia Commonwealth University; and

WHEREAS, over the course of her extensive career, she has taught at all levels, from kindergarten, elementary school, and special needs classes to high school and medical school; in 1970, she founded the Creative Preschool Kindergarten in Boston, Massachusetts, which continues to boast a three-year waiting list for admission; and

WHEREAS, in 1987, Elizabeth Brown, alongside Dr. Paul E. Brown, Jr., and Dr. Mae Votow, began a new program helping new medical students at the James H. Quillen College of Medicine with issues surrounding grief and patient care; she currently serves as a clinical professor of medicine for the medical school and teaches physician assistant students at Emory and Henry University and Milligan University; and

WHEREAS, a respected practitioner and prolific author, Elizabeth Brown is the author of six books: *Sunrise Tomorrow*, which was given to every police chaplain in the United States; *Surviving the Loss of a Child; The Joy Choice; Living Successfully with Screwed Up People*, a top-selling counseling book; *Surviving the Death of a Child: Hope for Grieving Parents*; *Working*

Successfully with Screwed Up People; and Standing Up When the World Falls Down Around You: and

WHEREAS Mrs. Brown is also a frequent speaker on radio and television and has served as keynote speaker at seminars and conferences across the country, including those presented by Hospice, Contact, Christian Women's Clubs, Widowed Persons Associations, and Compassionate Friends, Christian Medical and Dental Society, Good News, and the Police Chaplains Tennessee Association; and

WHEREAS, Elizabeth Brown has served her community through various leadership roles on community boards for organizations such as the Johnson City Symphony, Johnson City Medical Center's Children's Hospital, Tri-County Medical Association, Massengill Pharmacy Company Drug Review Board, and East Tennessee State University (ETSU) Foundation, President's Circle, and Board of Visitors; and

WHEREAS, often duly honored for her good work, Elizabeth Brown is the recipient of the DeFriece Humanitarian Faith Award, Tri-Cities Benefactor Award, Health Care Heroes

Distinguished Servicer Award and Cup of Kindness Award, Leaders in Christian Service Award, and Tribute to Women Award, and she has been named a Lifetime Member for excellence in
