WHEREAS, his brother, the late Edward Cureton, also served as Knoxville's fire chief (2002-2004); and

WHEREAS, Chief Cureton was a member of Sevier Heights Baptist Church; and WHEREAS, a lifetime member of the International Fire Chiefs Association, he had proudly served in the Tennessee Air National Guard; and

WHEREAS, Bruce Cureton was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Chief Cureton is survived by his daughters, Melissa Cureton (Anthony),
Mary Beth Cooper, and Jennifer Buckner (John); stepson, Mike Lawson; son-in-law, Ted
Farmer; grandchildren, Alanna Farmer, Sam Clanton, Jordan Norton (Noah), and Jenna and Joli
Buckner; great-grandson, Kyson Norton; numerous adored cousins, nieces, and nephews; and
special friend and former executive assistant, Vicky Dalton; and

WHEREAS, he was preceded in death by his loving wife, Glenda Cureton; parents, Pat and Mary Ellen Cureton; brother, Edward Cureton; sister, Linda Winn; and stepdaughter, Tracy Farmer; and
