WHEREAS, he was a member of the Veterans of Foreign Affairs and the Fraternal Order of Police Percy Priest Lodge #85, where he served as treasurer and in other capacities;

alongside his brother, David Stolinsky, who also serves in law enforcement, Kevin Stolinsky worked on many projects with both the Fraternal Order of Police and the Concerns of Police Survivors; and
