WHEREAS, a trusted leader in his profession, Mr. Byrd has also served as vice president and a board member of the East Tennessee Trustee's Association (ETTA) and was the 2011 president of the Tennessee County Trustee's Association, having previously served the association as secretary/treasurer; and

WHEREAS, often duly honored for his good work, Mr. Byrd was inducted as the ETTA's Trustee of the Year in 2004; and

WHEREAS, throughout his many successes, Jimmy D. Byrd has been grateful for the love and support of his wife, Mary Lois Byrd, and their daughters, Sara and Jessica Byrd; and

WHEREAS, Mr. Byrd is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and he should be specially recognized on the occasion of his retirement; now, therefore,
