## A BILL

To provide for a 10-percent reduction in pay for Members  
of Congress, the President, and the Vice President.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the  
5 “Savings Start With Us Act of 2011”.

6 (b) **FINDINGS.**—Congress finds the following:

7 (1) It is important to bring the Nation’s spend-  
8 ing under control and balance the budget.

1           (2) Taxpayers all over the Nation are making  
2 do with less money.

3           (3) Congress has asked Federal agencies to  
4 make major cuts to their budgets.

5           (4) Members of Congress must do their share  
6 to cut spending and reduce their salaries.

7 **SEC. 2. REDUCTION IN PAY FOR MEMBERS OF CONGRESS.**

8           (a) REDUCTION.—Notwithstanding any other provi-  
9 sion of law, the annual rate of pay for each Member of  
10 Congress shall be equal to—

11           (1) for pay periods occurring during 2013, the  
12 applicable rate in effect for pay periods occurring  
13 during 2011 reduced by 10 percent, rounded to the  
14 nearest multiple of \$100 (or, if midway between  
15 multiples of \$100, to the next higher multiple of  
16 \$100); and

17           (2) for subsequent pay periods, the applicable  
18 rate during 2013, subject to adjustment under para-  
19 graph (2) of section 601(a) of the Legislative Reor-  
20 ganization Act of 1946 (2 U.S.C. 31(2)).

21           (b) MEMBER OF CONGRESS DEFINED.—For pur-  
22 poses of this Act, the term “Member of Congress” means  
23 an individual serving in a position under subparagraph  
24 (A), (B), or (C) of section 601(a) of the Legislative Reor-  
25 ganization Act of 1946 (2 U.S.C. 31).

1 **SEC. 3. REDUCTION IN PAY FOR PRESIDENT AND VICE**  
2 **PRESIDENT.**

3 (a) PRESIDENT.—

4 (1) REDUCTION.—Section 102 of title 3, United  
5 States Code, is amended by striking “\$400,000”  
6 and inserting “\$360,000”.

7 (2) EFFECTIVE DATE.—The amendment made  
8 by paragraph (1) shall apply to pay periods begin-  
9 ning on or after January 1, 2013.

10 (b) VICE PRESIDENT.—Notwithstanding any other  
11 provision of law, the per annum rate of salary for the Vice  
12 President of the United States shall be equal to—

13 (1) for pay periods occurring during 2013, the  
14 applicable rate in effect for pay periods occurring  
15 during 2011 reduced by 10 percent, rounded to the  
16 nearest multiple of \$100 (or, if midway between  
17 multiples of \$100, to the next higher multiple of  
18 \$100); and

19 (2) for subsequent pay periods, the applicable  
20 rate during 2013, subject to adjustment under sec-  
21 tion 104(a) of title 3, United States Code.
