- To amend the Morris K. Udall Scholarship and Excellence in National Environmental and Native American Public Policy Act of 1992 to honor the legacy of Stewart L. Udall, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Morris K. Udall Schol-
- 3 arship and Excellence in National Environmental Policy
- 4 Amendments Act of 2009".
- 5 SEC. 2. SHORT TITLE.
- 6 Section 1 of the Morris K. Udall Scholarship and Ex-
- 7 cellence in National Environmental and Native American
- 8 Public Policy Act of 1992 (20 U.S.C. 5601 note; Public
- 9 Law 102–259) is amended to read as follows:
- 10 "SECTION 1. SHORT TITLE.
- 11 "This Act may be cited as the 'Morris K. Udall and
- 12 Stewart L. Udall Foundation Act'.".
- 13 SEC. 3. FINDINGS.
- 14 Section 3 of the Morris K. Udall and Stewart L.
- 15 Udall Foundation Act (20 U.S.C. 5601) is amended—
- 16 (1) in paragraph (3), by striking "and" at the
- 17 end;
- 18 (2) in paragraph (4), by striking the period at
- the end and inserting a semicolon; and
- 20 (3) by adding at the end the following:
- 21 "(5) the Foundation—
- "(A) since 1995, has operated exceptional
- scholarship, internship, and fellowship programs
- for areas of study related to the environment
- and Native American tribal policy and health
- 26 care;

1	"(B) since 1999, has provided valuable en-
2	vironmental conflict resolution services and
3	leadership through the United States Institute
4	for Environmental Conflict Resolution; and
5	"(C) is committed to continue making a
6	substantial contribution toward public policy in
7	the future by—
8	"(i) playing a significant role in devel-
9	oping the next generation of environmental
10	and Native American leaders; and
11	"(ii) working with current leaders to
12	improve decisionmaking on—
13	"(I) challenging environmental,
14	energy, and related economic prob-
15	lems; and
16	"(II) tribal governance and eco-
17	nomic issues;
18	"(6) Stewart L. Udall, as a member of Con-
19	gress, Secretary of the Interior, environmental law-
20	yer, and author, has provided distinguished national
21	leadership in environmental and Native American
22	policy for more than 50 years;
23	"(7) as Secretary of the Interior from 1961 to
24	1969, Stewart L. Udall oversaw the creation of 4
25	national parks, 6 national monuments, 8 national

1	seashores and lakeshores, 9 recreation areas, 20 his-
2	toric sites, and 56 wildlife refuges; and
3	"(8) it is fitting that the leadership and vision
4	of Stewart L. Udall in the areas of environmental
5	and Native American policy be jointly honored with
6	that of Morris K. Udall through the foundation
7	bearing the Udall name.".
8	SEC. 4. DEFINITIONS.

11	(1) in paragraph (1), by striking "Morris K.

15	and Excellence in National Environmental Policy"
16	and inserting "and Stewart L. Udall"; and
17	(3) in paragraph (9), by striking "Scholarship
18	and Excellence in National Environmental Policy"
19	and inserting "and Stewart L. Udall".
20	SEC. 5. ESTABLISHMENT OF FOUNDATION.
21	Section 5 of the Morris K. Udall and Stewart L.
22	Udall Foundation Act (20 U.S.C. 5603) is amended—
23	(1) in the section heading, by striking " SCHOL-

1	RONMENTAL POLICY" and inserting "AND STEW-
2	ART L. UDALL";
3	(2) in subsection (a), by striking "Scholarship
4	and Excellence in National Environmental Policy"
5	and inserting "and Stewart L. Udall"; and
6	(3) in subsection $(f)(2)$, by striking "the rate
7	specified for employees in level IV of the Executive
8	Schedule under section 5315 of title 5, United
9	States Code" and inserting "a rate determined by
10	the Board in accordance with section 5383 of title
11	5, United States Code".
12	SEC. 6. AUTHORITY OF FOUNDATION.
13	Section 7 of the Morris K. Udall and Stewart L.
14	Udall Foundation Act (20 U.S.C. 5605) is amended—
15	(1) in subsection (a)(5)—
16	(A) in subparagraph (C), by striking
17	"and" at the end;
18	(B) in subparagraph (D), by striking the
19	period at the end and inserting "; and"; and
20	(C) by adding at the end the following:
21	"(E) to conduct training, research, and
22	other activities under section 6(7)."; and
23	(2) by striking subsection (b) and inserting the
24	following:

- 1 "(b) Udall Scholars.—Recipients of scholarships,
- 2 fellowships, and internships under this Act shall be known
- 3 as 'Udall Scholars', 'Udall Fellows', and 'Udall Interns',
- 4 respectively.".
- 5 SEC. 7. ESTABLISHMENT OF TRUST FUND.
- 6 Section 8 of the Morris K. Udall and Stewart L.
- 7 Udall Foundation Act (20 U.S.C. 5606) is amended—
- 8 (1) in the section heading, by striking "**SCHOL-**
- 9 ARSHIP AND EXCELLENCE IN NATIONAL ENVI-
- 10 **RONMENTAL POLICY**" and inserting "AND STEW-
- 11 **ART L. UDALL**"; and
- 12 (2) in subsection (a), by striking "Scholarship
- and Excellence in National Environmental Policy"
- and inserting "and Stewart L. Udall".
- 15 SEC. 8. EXPENDITURES AND AUDIT OF TRUST FUND.
- Section 9(a) of the Morris K. Udall and Stewart L.
- 17 Udall Foundation Act (20 U.S.C. 5607(a)) is amended by
- 18 inserting before the period at the end the following: ", in-
- 19 cluding a reasonable amount for official reception and rep-
- 20 resentation expenses, as determined by the Board, not to
- 21 exceed \$5,000 for a fiscal year".

1	SEC. 9. USE OF INSTITUTE BY FEDERAL AGENCY OR OTHER
2	ENTITY.
3	Section 11 of the Morris K. Udall and Stewart L.
4	Udall Foundation Act (20 U.S.C. 5607b) is amended by
5	adding at the end the following:
6	"(f) AGENCY MANAGEMENT OR CONTROL.—Use of
7	the Foundation or Institute to provide independent and
8	impartial assessment, mediation, or other dispute or con-
9	flict resolution under this section shall not be considered
10	to be the establishment or use of an advisory committee
11	within the meaning of the Federal Advisory Committee
12	Act (5 U.S.C. App.).".
13	SEC. 10. ADMINISTRATIVE PROVISIONS.
14	Section 12(a) of the Morris K. Udall and Stewart L.
15	Udall Foundation Act (20 U.S.C. 5608(a)) is amended—
16	(1) by striking paragraph (1) and inserting the
17	following:
18	"(1)(A) appoint such personnel as may be nec-
19	essary to carry out the provisions of this Act, with-
20	out regard to the provisions of title 5, United States
21	Code, governing appointments in the competitive
22	service; and
23	"(B) fix the compensation of the personnel ap-
24	pointed under subparagraph (A) at a rate not to ex-
25	ceed the maximum rate for employees in grade GS-
26	15 of the General Schedule under section 5332 of

- 1 title 5, United States Code, except that up to 4 em-
- 2 ployees (in addition to the Executive Director under
- section 5(f)(2) may be paid at a rate determined by
- 4 the Board in accordance with section 5383 of that
- 5 title.";
- 6 (2) in paragraph (6), by striking "and" at the
- $7 \quad \text{end};$
- 8 (3) by redesignating paragraph (7) as para-
- 9 graph (8); and
- 10 (4) by inserting after paragraph (6) the fol-
- 11 lowing:
- "(7) to rent office space in the District of Co-
- lumbia or its environs; and".
- 14 SEC. 11. AUTHORIZATION OF APPROPRIATIONS.
- 15 Section 13 of the Morris K. Udall and Stewart L.
- 16 Udall Foundation Act (20 U.S.C. 5609) is amended—
- 17 (1) in subsection (a), by striking "is authorized
- to be appropriated to the Trust Fund \$40,000,000"
- and inserting "are authorized to be appropriated to
- the Trust Fund such sums as are necessary"; and
- 21 (2) by striking subsection (b) and inserting the
- following:
- 23 "(b) Environmental Dispute Resolution
- 24 Fund.—There are authorized to be appropriated to the
- 25 Environmental Dispute Resolution Fund established

- 1 under section 10(a) such sums as are necessary for the
- 2 operating costs of the Institute.".
