## A BILL

To amend the Public Health Service Act to revise and extend projects relating to children and to provide access to school-based comprehensive mental health programs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Mental Health Services*  
5 *for Students Act of 2020”.*

6 **SEC. 2. AMENDMENTS TO THE PUBLIC HEALTH SERVICE**

7 **ACT.**

8 *(a) TECHNICAL AMENDMENTS.—The second part G*  
9 *(relating to services provided through religious organiza-*  
10 *tions) of title V of the Public Health Service Act (42 U.S.C.*  
11 *290kk et seq.) is amended—*

12 *(1) by redesignating such part as part J; and*

13 *(2) by redesignating sections 581 through 584 as*  
14 *sections 596 through 596C, respectively.*

15 *(b) SCHOOL-BASED MENTAL HEALTH AND CHIL-*  
16 *DREN.—Section 581 of the Public Health Service Act (42*  
17 *U.S.C. 290hh) (relating to children and violence) is amend-*  
18 *ed to read as follows:*

19 **“SEC. 581. SCHOOL-BASED MENTAL HEALTH; CHILDREN**  
20 **AND ADOLESCENTS.**

21 *“(a) IN GENERAL.—The Secretary, in consultation*  
22 *with the Secretary of Education, shall, through grants, con-*  
23 *tracts, or cooperative agreements awarded to eligible entities*  
24 *described in subsection (c), provide comprehensive school-*  
25 *based mental health services and supports to assist children*

1 *in local communities and schools (including schools funded*  
2 *by the Bureau of Indian Education) dealing with trau-*  
3 *matic experiences, grief, bereavement, risk of suicide, and*  
4 *violence. Such services and supports shall be—*

5           “(1) *developmentally, linguistically, and cul-*  
6           *turally appropriate;*

7           “(2) *trauma-informed; and*

8           “(3) *incorporate positive behavioral interven-*  
9           *tions and supports.*

10          “(b) *ACTIVITIES.—Grants, contracts, or cooperative*  
11 *agreements awarded under subsection (a), shall, as appro-*  
12 *priate, be used for—*

13           “(1) *implementation of school and community-*  
14           *based mental health programs that—*

15                   “(A) *build awareness of individual trauma*  
16                   *and the intergenerational, continuum of impacts*  
17                   *of trauma on populations;*

18                   “(B) *train appropriate staff to identify,*  
19                   *and screen for, signs of trauma exposure, mental*  
20                   *health disorders, or risk of suicide; and*

21                   “(C) *incorporate positive behavioral inter-*  
22                   *ventions, family engagement, student treatment,*  
23                   *and multigenerational supports to foster the*  
24                   *health and development of children, prevent men-*

1           *tal health disorders, and ameliorate the impact*  
2           *of trauma;*

3           “(2) *technical assistance to local communities*  
4           *with respect to the development of programs described*  
5           *in paragraph (1);*

6           “(3) *facilitating community partnerships among*  
7           *families, students, law enforcement agencies, edu-*  
8           *cation agencies, mental health and substance use dis-*  
9           *order service systems, family-based mental health*  
10           *service systems, child welfare agencies, health care*  
11           *providers (including primary care physicians, mental*  
12           *health professionals, and other professionals who spe-*  
13           *cialize in children’s mental health such as child and*  
14           *adolescent psychiatrists), institutions of higher edu-*  
15           *cation, faith-based programs, trauma networks, and*  
16           *other community-based systems to address child and*  
17           *adolescent trauma, mental health issues, and violence;*  
18           *and*

19           “(4) *establishing mechanisms for children and*  
20           *adolescents to report incidents of violence or plans by*  
21           *other children, adolescents, or adults to commit vio-*  
22           *lence.*

23           “(c) *REQUIREMENTS.—*

1           “(1) *IN GENERAL.*—*To be eligible for a grant,*  
2           *contract, or cooperative agreement under subsection*  
3           *(a), an entity shall be a partnership that includes—*

4                   “(A) *a State educational agency, as defined*  
5                   *in section 8101 of the Elementary and Sec-*  
6                   *ondary Education Act of 1965, in coordination*  
7                   *with one or more local educational agencies, as*  
8                   *defined in section 8101 of the Elementary and*  
9                   *Secondary Education Act of 1965, or a consor-*  
10                   *tium of any entities described in subparagraph*  
11                   *(B), (C), (D), or (E) of section 8101(30) of such*  
12                   *Act; and*

13                   “(B) *at least 1 community-based mental*  
14                   *health provider, including a public or private*  
15                   *mental health entity, health care entity, family-*  
16                   *based mental health entity, trauma network, or*  
17                   *other community-based entity, as determined by*  
18                   *the Secretary (and which may include addi-*  
19                   *tional entities such as a human services agency,*  
20                   *law enforcement or juvenile justice entity, child*  
21                   *welfare agency, agency, an institution of higher*  
22                   *education, or another entity, as determined by*  
23                   *the Secretary).*

24           “(2) *COMPLIANCE WITH HIPAA.*—*Any patient*  
25           *records developed by covered entities through activities*

1        *under the grant shall meet the regulations promul-*  
2        *gated under section 264(c) of the Health Insurance*  
3        *Portability and Accountability Act of 1996.*

4            “(3) *COMPLIANCE WITH FERPA.*—Section 444 of  
5        *the General Education Provisions Act (commonly*  
6        *known as the ‘Family Educational Rights and Pri-*  
7        *vacancy Act of 1974’)* shall apply to any entity that is  
8        *a member of the partnership in the same manner that*  
9        *such section applies to an educational agency or in-*  
10       *stitution (as that term is defined in such section).*

11          “(d) *GEOGRAPHICAL DISTRIBUTION.*—The Secretary  
12       *shall ensure that grants, contracts, or cooperative agree-*  
13       *ments under subsection (a) will be distributed equitably*  
14       *among the regions of the country and among urban and*  
15       *rural areas.*

16          “(e) *DURATION OF AWARDS.*—With respect to a grant,  
17       *contract, or cooperative agreement under subsection (a), the*  
18       *period during which payments under such an award will*  
19       *be made to the recipient shall be 5 years, with options for*  
20       *renewal.*

21          “(f) *EVALUATION AND MEASURES OF OUTCOMES.*—

22            “(1) *DEVELOPMENT OF PROCESS.*—The Assistant  
23       *Secretary shall develop a fiscally appropriate process*  
24       *for evaluating activities carried out under this sec-*  
25       *tion. Such process shall include—*

1           “(A) the development of guidelines for the  
2           submission of program data by grant, contract,  
3           or cooperative agreement recipients;

4           “(B) the development of measures of out-  
5           comes (in accordance with paragraph (2)) to be  
6           applied by such recipients in evaluating pro-  
7           grams carried out under this section; and

8           “(C) the submission of annual reports by  
9           such recipients concerning the effectiveness of  
10          programs carried out under this section.

11          “(2) *MEASURES OF OUTCOMES.*—*The Assistant*  
12          *Secretary shall develop measures of outcomes to be ap-*  
13          *plied by recipients of assistance under this section to*  
14          *evaluate the effectiveness of programs carried out*  
15          *under this section, including outcomes related to the*  
16          *student, family, and local educational systems sup-*  
17          *ported by this Act.*

18          “(3) *SUBMISSION OF ANNUAL DATA.*—*An eligible*  
19          *entity described in subsection (c) that receives a*  
20          *grant, contract, or cooperative agreement under this*  
21          *section shall annually submit to the Assistant Sec-*  
22          *retary a report that includes data to evaluate the suc-*  
23          *cess of the program carried out by the entity based on*  
24          *whether such program is achieving the purposes of the*  
25          *program. Such reports shall utilize the measures of*



1 *outcomes under paragraph (2) in a reasonable man-*  
2 *ner to demonstrate the progress of the program in*  
3 *achieving such purposes.*

4 “(4) *EVALUATION BY ASSISTANT SECRETARY.—*  
5 *Based on the data submitted under paragraph (3),*  
6 *the Assistant Secretary shall annually submit to Con-*  
7 *gress a report concerning the results and effectiveness*  
8 *of the programs carried out with assistance received*  
9 *under this section.*

10 “(5) *LIMITATION.—An eligible entity shall use*  
11 *not more than 20 percent of amounts received under*  
12 *a grant under this section to carry out evaluation ac-*  
13 *tivities under this subsection.*

14 “(g) *INFORMATION AND EDUCATION.—The Secretary*  
15 *shall disseminate best practices based on the findings of the*  
16 *knowledge development and application under this section.*

17 “(h) *AMOUNT OF GRANTS AND AUTHORIZATION OF AP-*  
18 *PROPRIATIONS.—*

19 “(1) *AMOUNT OF GRANTS.—A grant under this*  
20 *section shall be in an amount that is not more than*  
21 *\$2,000,000 for each of the first 5 fiscal years following*  
22 *the date of enactment of the Mental Health Services*  
23 *for Students Act of 2019. The Secretary shall deter-*  
24 *mine the amount of each such grant based on the pop-*

1        *ulation of children up to age 21 of the area to be*  
2        *served under the grant.*

3                *“(2) AUTHORIZATION OF APPROPRIATIONS.—*  
4        *There is authorized to be appropriated to carry out*  
5        *this section, \$130,000,000 for each of fiscal years 2021*  
6        *through 2024.”.*

7        *(c) CONFORMING AMENDMENT.—Part G of title V of*  
8        *the Public Health Service Act (42 U.S.C. 290hh et seq.),*  
9        *as amended by subsection (b), is further amended by strik-*  
10       *ing the part designation and heading and inserting the fol-*  
11       *lowing:*

12        **“PART G—SCHOOL-BASED MENTAL HEALTH”.**
