AN ACT

To amend the Veterans Access, Choice, and Accountability Act of 2014 to authorize the Secretary of Veterans Affairs to provide for an operation on a live donor for purposes of conducting a transplant procedure for a veteran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Veterans Transplant
3 Coverage Act of 2017”.

4 **SEC. 2. AUTHORIZATION TO PROVIDE FOR OPERATIONS ON**
5 **LIVE DONORS FOR PURPOSES OF CON-**
6 **DUCTING TRANSPLANT PROCEDURES FOR**
7 **VETERANS.**

8 Section 101 of the Veterans Access, Choice, and Ac-
9 countability Act of 2014 (Public Law 113–146; 38 U.S.C.
10 1701 note) is amended by adding after subsection (t) the
11 following new subsection:

12 “(u) **TRANSPLANT PROCEDURES WITH LIVE DO-**
13 **NORS AND RELATED SERVICES.**—

14 “(1) **IN GENERAL.**—Subject to paragraphs (2)
15 and (3), in a case in which a veteran is eligible for
16 a transplant procedure from the Department, the
17 Secretary may provide for an operation on a live
18 donor to carry out such procedure for such veteran,
19 notwithstanding that the live donor may not be eligi-
20 ble for health care from the Department.

21 “(2) **OTHER SERVICES.**—Subject to the avail-
22 ability of appropriations for such purpose, the Sec-
23 retary shall furnish to a live donor any care or serv-
24 ices before and after conducting the transplant pro-
25 cedure under paragraph (1) that may be required in
26 connection with such procedure.

1 “(3) USE OF NON-DEPARTMENT FACILITIES.—
2 In carrying out this subsection, the Secretary may
3 provide for the operation described in paragraph (1)
4 on a live donor and furnish to the live donor the
5 care and services described in paragraph (2) at a
6 non-Department facility pursuant to an agreement
7 entered into by the Secretary under this section. The
8 live donor shall be deemed to be an individual eligi-
9 ble for hospital care and medical services at a non-
10 Department facility pursuant to such an agreement
11 solely for the purposes of receiving such operation,
12 care, and services at the non-Department facility.”.
