## AN ACT

To require the Department of State to establish a policy regarding the use of location-tracking consumer devices by employees at diplomatic and consular facilities, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Protecting Diplomats  
3 from Surveillance Through Consumer Devices Act”.

4 **SEC. 2. SECURING UNITED STATES DIPLOMATIC AND CON-**  
5 **SULAR FACILITIES AGAINST CYBERSURVEIL-**  
6 **LANCE.**

7 (a) **POLICY ON LOCATION-TRACKING CONSUMER DE-**  
8 **VICES.**—Not later than 60 days after the date of the en-  
9 actment of this Act, the Secretary of State shall establish  
10 a policy on the use of location-tracking consumer devices,  
11 including GPS-enabled devices, at United States diplo-  
12 matic and consular facilities by United States Government  
13 employees, contractors, locally employed staff, and mem-  
14 bers of other agencies deployed to or stationed at such  
15 facilities.

16 (b) **SECURITY BRIEFING.**—Existing and new employ-  
17 ees at United States diplomatic and consular facilities, in-  
18 cluding contractors, locally employed staff, and members  
19 of other agencies deployed to or stationed at such facili-  
20 ties, shall, as a part of the security briefings provided to  
21 such employees, be informed of the policy described in sub-  
22 section (a) and given instructions on the use of location-  
23 tracking consumer devices both on and off the premises  
24 of such facilities.

25 (c) **COORDINATION.**—The Secretary of State shall co-  
26 ordinate with the heads of any other agencies whose em-

1 ployees are deployed to or stationed at United States dip-  
2 lomatic and consular facilities in the formulation of the  
3 policy described in subsection (a) and the dissemination  
4 of such policy pursuant to subsection (b).

5 (d) REPORT.—Not later than 30 days after the for-  
6 mulation of the policy described in subsection (a), the Sec-  
7 retary of State shall submit to the Committee on Foreign  
8 Affairs of the House of Representatives and the Com-  
9 mittee on Foreign Relations of the Senate a report on the  
10 details of such policy.
