AN ACT

To require the Secretary of the Treasury to mint coins in recognition of the 60th Anniversary of the Naismith Memorial Basketball Hall of Fame.

- 1 Be it enacted by the Senate and House of Representa-
- ${\it 2\ tives\ of\ the\ United\ States\ of\ America\ in\ Congress\ assembled},$

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Naismith Memorial
- 3 Basketball Hall of Fame Commemorative Coin Act".
- 4 SEC. 2. FINDINGS.
- 5 The Congress finds the following:
- 6 (1) On December 21, 1891, a young physical 7 education instructor named James Naismith, intro-8 duced the game of "basket ball" to his physical edu-
- 9 cation class, in Springfield, Massachusetts.
- 10 (2) In 1959, the Naismith Memorial Basketball
- 11 Hall of Fame was founded and dedicated to the
- game's creator Dr. James Naismith, in Springfield,
- 13 MA, "The Birthplace of Basketball" and became the
- first and only museum to honor the game at all lev-
- els around the world.
- 16 (3) The Naismith Memorial Basketball Hall of
- 17 Fame honors players who have achieved greatness,
- exemplary coaches, referees and other major contrib-
- utors to the sport of basketball. The Inaugural Hall
- of Fame Class of 1959 had seventeen honorees who
- 21 were inducted, including Dr. James Naismith,
- George Mikan, Forrest C. Allen, Angelo Luisetti,
- Original Celtics and First Team.
- 24 (4) The Naismith Memorial Basketball Hall of
- Fame is recognized throughout the world as the pre-
- 26 mier institution entrusted with recording and dis-

- seminating the history of the game of basketball and recognizing and honoring the achievements of its greatest players, coaches, and contributors.
 - (5) The Naismith Memorial Basketball Hall of Fame provides an entertaining, enriching experience and is known for its educational outreach programs and celebrates and promotes positive core values demonstrated by basketball's hallowed heroes and its founder.
 - (6) Basketball is one of America's national treasures, with its fast pace which reflects the freedom of expression and the modern experience of life in the 21st century.
 - (7) Since its opening in 1959, the Naismith Memorial Basketball Hall of Fame is home to the largest collection of basketball memorabilia in the world, including more than 30,000 three-dimensional objects, 800,000 photographs, and 1.5 million documents.
 - (8) The Naismith Memorial Basketball Hall of Fame welcomes more than 6 million visitors interested in discovering the rich history of the game through its stories, its personalities, and its most celebrated moments.

- 1 (9) The Naismith Memorial Basketball Hall of 2 Fame reaches over 7 million Americans through its 3 educational programs, events, exhibits, social media, 4 and its interactive website.
 - (10) The Naismith Memorial Basketball Hall of Fame's customized educational programs use basketball to teach young students around the world the important lessons on a variety of topics including: financial literacy, mathematics, civil rights, leadership of character, women's and men's history, and geography.
 - (11) The Naismith Memorial Basketball Hall of Fame will lead the celebration of the 60th Anniversary of Basketball and will partner with a select group of constituents including the National Basketball Association, the National Collegiate Athletic Association, and USA Basketball in commemorating the game throughout the 2019–2020 basketball season.

21 (a) DENOMINATIONS.—In recognition and celebration 22 of the Naismith Memorial Basketball Hall of Fame, the 23 Secretary of the Treasury (hereafter in this Act referred 24 to as the "Secretary") shall mint and issue the following 25 coins:

(c) Numismatic Items.—For purposes of sections

5134 and 5136 of title 31, United States Code, all coins minted under this Act shall be considered to be numis-3 matic items. 5 (d) Dome Shape.—The coins minted under this Act shall be in the shape of a dome. 6 SEC. 4. DESIGN OF COINS. 8 (a) IN GENERAL.—The design for the coins minted under this Act shall be— 10 (1) selected by the Secretary after consultation 11 with the Commission of Fine Arts; and 12 (2) reviewed by the Citizens Coinage Advisory 13 Committee. 14 (b) Designations and Inscriptions.—On each 15 coin minted under this Act there shall be— 16 (1) a designation of the value of the coin; 17 (2) an inscription of the year "2020"; and 18 (3) inscriptions of the words "Liberty", "In 19 God We Trust", "United States of America", and 20 "E Pluribus Unum". 21 (c) Selection and Approval Process for Ob-22 VERSE DESIGN.— 23 (1) IN GENERAL.—The Secretary shall hold a 24 competition to determine the design of the common 25 obverse of the coins minted under this Act, with

- such design being emblematic of the game of basket-ball.
- 3 (2) SELECTION AND APPROVAL.—Proposals for 4 the design of coins minted under this Act may be 5 submitted in accordance with the design selection 6 and approval process developed by the Secretary in 7 the sole discretion of the Secretary.
 - (3) Proposals.—As part of the competition described in this subsection, the Secretary may accept proposals from artists, engravers and other employees of the United States Mint, other Government employees, and members of the general public.
 - (4) Compensation.—The Secretary shall determine compensation for the winning design under this subsection, which shall be not less than \$5,000. The Secretary shall take into account this compensation amount when determining the sale price described in section 6(a).
- 19 (d) REVERSE DESIGN.—The design on the common 20 reverse of the coins minted under this Act shall depict a 21 basketball.
- 22 SEC. 5. ISSUANCE OF COINS.
- 23 (a) QUALITY OF COINS.—Coins minted under this 24 Act shall be issued in uncirculated and proof qualities.

SEC. 7. SURCHARGES.

- 2 (a) In General.—All sales of coins minted under
- 3 this Act shall include a surcharge as follows:
- 4 (1) A surcharge of \$35 per coin for the \$5 coin.
- 5 (2) A surcharge of \$10 per coin for the \$1 coin.
- 6 (3) A surcharge of \$5 per coin for the half-dol-
- 7 lar coin.
- 8 (b) Distribution.—Subject to section 5134(f) of
- 9 title 31, United States Code, all surcharges received by
- 10 the Secretary from the sale of coins issued under this Act
- 11 shall be promptly paid by the Secretary to the Naismith
- 12 Memorial Basketball Hall of Fame to fund an endowment
- 13 that will enable increased operations and educational pro-
- 14 gramming of the Naismith Memorial Basketball Hall of
- 15 Fame.
- 16 (c) Audits.—The Naismith Memorial Basketball
- 17 Hall of Fame shall be subject to the audit requirements
- 18 of section 5134(f)(2) of title 31, United States Code, with
- 19 regard to the amounts received under subsection (b).
- 20 (d) Limitation.—Notwithstanding subsection (a),
- 21 no surcharge may be included with respect to the issuance
- 22 under this Act of any coin during a calendar year if, as
- 23 of the time of such issuance, the issuance of such coin
- 24 would result in the number of commemorative coin pro-
- 25 grams issued during such year to exceed the annual com-
- 26 memorative coin program issuance limitation under sec-

- 1 tion 5112(m)(1) of title 31, United States Code (as in ef-
- 2 fect on the date of the enactment of this Act). The Sec-
- 3 retary of the Treasury may issue guidance to carry out
- 4 this subsection.
