# **A BILL**

To amend title 10, United States Code, to expand eligibility to certain military retirees for concurrent receipt of veterans' disability compensation and retired pay or combat-related special compensation, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Major Richard Star*  
5 *Act”.*

6 **SEC. 2. EXPANSIONS OF ELIGIBILITY TO CERTAIN MILITARY**  
7 **RETIREES FOR CONCURRENT RECEIPT OF**  
8 **VETERANS’ DISABILITY COMPENSATION AND**  
9 **RETIRED PAY OR COMBAT-RELATED SPECIAL**  
10 **COMPENSATION.**

11        *(a) INCLUSION OF CHAPTER 61 DISABILITY RETIREES*  
12 *WITH FEWER THAN 20 YEARS OF SERVICE WHO ARE ELI-*  
13 *GIBLE FOR COMBAT-RELATED SPECIAL COMPENSATION.—*  
14 *Section 1413a(b)(3) of title 10, United States Code, is*  
15 *amended—*

16            *(1) in subparagraph (A), by striking “In” and*  
17 *inserting “Subject to subparagraph (B), in”; and*

18            *(2) in subparagraph (B), by striking “In the*  
19 *case of” and all that follows and inserting “The re-*  
20 *tired pay of an eligible combat-related disabled uni-*  
21 *formed services retiree, who is retired under chapter*  
22 *61 of this title with fewer than 20 years of creditable*  
23 *service, is not subject to reduction under sections 5304*  
24 *and 5305 of title 38.”.*

25        *(b) TECHNICAL AND CONFORMING AMENDMENTS.—*

1           (1) *SECTION HEADING.*—*The heading of section*  
 2           *1414 of such title is amended to read as follows:*

3           **“§ 1414. Members eligible for retired pay who are also**  
 4                           ***eligible for veterans’ disability compensa-***  
 5                           ***tion: concurrent receipt”.***

6           (2) *TABLE OF SECTIONS.*—*The item relating to*  
 7           *such section 1414 in the table of sections at the begin-*  
 8           *ning of chapter 71 of such title is amended to read*  
 9           *as follows:*

          “1414. *Members eligible for retired pay who are also eligible for veterans’ dis-*  
   *ability compensation: concurrent receipt.”.*

10           (3) *CONFORMING AMENDMENTS REFLECTING END*  
 11           *OF CONCURRENT RECEIPT PHASE-IN PERIOD.*—*Such*  
 12           *section 1414 is further amended—*

13                           (A) *in subsection (a)(1)—*

14   (i) *by striking the second sentence; and*

15   (ii) *by striking subparagraphs (A) and*

16   (B);

17                           (B) *by striking subsection (c) and redesign-*  
 18                           *ating subsections (d) and (e) as subsections (c)*  
 19                           *and (d), respectively; and*

20                           (C) *in subsection (d), as redesignated, by*  
 21                           *striking paragraphs (3) and (4).*

22           (c) *EFFECTIVE DATE.*—*The amendments made by this*  
 23           *section shall take effect on the first day of the first month*  
 24           *beginning after the date of the enactment of this Act and*

- 1 *shall apply to payments for months beginning on or after*
- 2 *such date.*
