6 Not later than 60 days after the date of the enact-7 ment of this Act, the Securities and Exchange Commission 8 shall revise section 230.701(e) of title 17, Code of Federal 9 Regulations, so as to increase from \$5,000,000 to \$10,000,000 the aggregate sales price or amount of secu-10 11 rities sold during any consecutive 12-month period in excess of which the issuer is required under such section to 12 deliver an additional disclosure to investors. The Commis-13 14 sion shall index for inflation such aggregate sales price or amount every 5 years to reflect the change in the Con-15 sumer Price Index for All Urban Consumers published by 16 17 the Bureau of Labor Statistics, rounding to the nearest \$1,000,000. 18
