A BILL

To ensure that a private for-profit nursing home affected by a major disaster receives the same reimbursement as a public nursing home affected by a major disaster.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Nursing Home Emer-
- 5 gency Assistance Act".

1	SEC. 2. FEDERAL ASSISTANCE TO PRIVATE FOR-PROFIT
2	NURSING HOMES.
3	Title IV of the Robert T. Stafford Disaster Relief and
4	Emergency Assistance Act is amended by inserting after
5	section 408 (42 U.S.C. 5170 et seq.) the following:
6	"SEC. 409. FEDERAL ASSISTANCE TO PRIVATE FOR-PROFIT
7	NURSING HOMES.
8	"(a) In General.—Notwithstanding any other pro-
9	vision of this Act, the President may provide, from funds
10	made available to carry out this Act, reimbursement to
11	a private for-profit nursing home, for damage to, or an
12	expense incurred by, such nursing home during a major
13	disaster or emergency, in accordance with this section.
14	"(b) Eligibility.—A private for-profit nursing
15	home shall be eligible to receive reimbursement under sub-
16	section (a) if, as determined by the President, in consulta-
17	tion with the Governor of a State—
18	"(1) the damage to, or expense incurred by, the
19	nursing home was the result of a major disaster or
20	emergency;
21	"(2) the nursing home is located within 30
22	miles of the major disaster or emergency area; and
23	"(3) during the major disaster or emergency
24	the nursing home acted in accordance with any rel-
25	evant requirement that would apply to a private non-

- 2 bursement under this Act.
- 3 "(c) Limitation.—The amount of reimbursement
- 4 provided to a private for-profit nursing home under this
- 5 section shall not be greater than the amount of reimburse-
- 6 ment available under this Act for a public or private non-
- 7 profit nursing home for similar damage or incurred ex-
- 8 penses after a major disaster or emergency.
- 9 "(d) Definition.—In this section, the term 'nursing
- 10 home' means an establishment with 3 or more beds that
- 11 provides nursing or personal care services to the older pop-
- 12 ulation, infirm, or chronically ill.".
