- To amend title 49, United States Code, to prohibit advance notice to certain individuals, including security screeners, of covert testing of security screening procedures for the purpose of enhancing transportation security at airports, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Catching Operational
- 5 Vulnerabilities by Ensuring Random Testing Act of 2011"
- 6 or the "COVERT Act of 2011".

2	TESTING TO SECURITY SCREENERS.
3	Section 44935 of title 49, United States Code, is
4	amended—
5	(1) by redesignating the second subsection (i),
6	relating to accessibility of computer-based training
7	facilities, as subsection (k); and
8	(2) by adding at the end the following:
9	"(1) Prohibition of Advance Notice to Secu-
10	RITY SCREENERS OF COVERT TESTING AND EVALUA-
11	TION.—
12	"(1) IN GENERAL.—The Secretary of Homeland
13	Security shall ensure that information concerning a
14	covert test of a transportation security system to be
15	conducted by a covert testing office, the Inspector
16	General of the Department of Homeland Security, or
17	the Government Accountability Office is not pro-
18	vided to any individual prior to the completion of the
19	test.
20	"(2) EXCEPTIONS.—Notwithstanding para-
21	graph (1) —
22	"(A) an individual may provide informa-
23	tion concerning a covert test of a transportation
24	security system to employees, officers, and con-
25	tractors of the Federal Government (including
26	military personnel); employees and officers of

State and local governments; and law enforcement officials, who are authorized to receive or directed to be provided such information by the Assistant Secretary of Homeland Security (Transportation Security Administration), the Inspector General of the Department of Homeland Security, or the Comptroller General of the United States, as the case may be; and

9 "(B) for the purpose of ensuring the secu-10 rity of any individual in the vicinity of a site 11 where a covert test of a transportation security 12 system is being conducted, an individual con-13 ducting the test may disclose his or her status 14 as an individual conducting the test to any ap-15 propriate individual if a security screener or 16 other individual who is not a covered employee 17 identifies the individual conducting the test as 18 a potential threat.

19 "(3) SPECIAL RULES FOR THE TRANSPOR20 TATION SECURITY ADMINISTRATION.—

21 "(A) MONITORING AND SECURITY OF
22 TESTING PERSONNEL.—The head of each covert
23 testing office shall ensure that a person or
24 group of persons conducting a covert test of a
25 transportation security system for the covert

1	testing office is accompanied at the site of the
2	test by a cover team comprised of one or more
3	employees of the covert testing office for the
4	purpose of monitoring the test and confirming
5	the identity of personnel involved in the test
6	under subparagraph (B).
7	"(B) RESPONSIBILITY OF COVER TEAM.—
8	Under this paragraph, a cover team for a covert
9	test of a transportation security system shall—
10	"(i) monitor the test; and
11	"(ii) for the purpose of ensuring the
12	security of any individual in the vicinity of
13	a site where the test is being conducted,
14	confirm, notwithstanding paragraph (1) ,
15	the identity of any individual conducting
16	the test to any appropriate individual if a
17	security screener or other individual who is
18	not a covered employee identifies the indi-
19	vidual conducting the test as a potential
20	threat.
21	"(C) AVIATION SCREENING.—Notwith-
22	standing subparagraph (A), the Transportation
23	Security Administration is not required to have
24	a cover team present during a test of the
25	screening of persons, carry-on items, or checked

1	baggage at an aviation security checkpoint at or
2	serving an airport if the test—
3	"(i) is approved by the Federal Secu-
4	rity Director for such airport; and
5	"(ii) is carried out under an aviation
6	screening assessment program of the De-
7	partment of Homeland Security.
8	"(D) USE OF OTHER PERSONNEL.—The
9	Transportation Security Administration may
10	use employees, officers, and contractors of the
11	Federal Government (including military per-
12	sonnel) and employees and officers of State and
13	local governments to conduct covert tests.
14	"(4) Impact study and report on covert
15	TESTING PROCEDURES.—
16	"(A) IMPACT STUDY.—The Secretary of
17	Homeland Security shall conduct a study of the
18	impact of the implementation of this subsection
19	on the Department of Homeland Security's ef-
20	forts to improve transportation security.
21	"(B) REQUIREMENTS.—The study under
22	subparagraph (A) shall include an assessment
23	of—

"(i) the impact of the implementation of this subsection on personnel of the De- partment of Homeland Security;"(ii) the impact of such implementa-
partment of Homeland Security;
"(ii) the impact of such implementa-
tion on information sharing within the De-
partment;
"(iii) best practices for integrating the
topic of covert testing into existing training
and testing programs for personnel of the
Department; and
"(iv) the effectiveness of covert testing
as a method to improve security.
"(C) REPORT.—Not later than 270 days
after the date of enactment of this subsection,
the Secretary shall submit to the Committee on
Homeland Security of the House of Representa-
tives and the Committee on Homeland Security
and Governmental Affairs of the Senate a re-
port that contains—
"(i) the results of the study under
subparagraph (A);
"(ii) recommendations for changes to
the training of personnel of the Depart-

1	ance with the requirements of this sub-
2	section; and
3	"(iii) recommendations to improve the
4	effectiveness of the implementation of this
5	subsection.
6	"(5) Definitions.—For purposes of this sub-
7	section, the following definitions apply:
8	"(A) APPROPRIATE INDIVIDUAL.—The
9	term 'appropriate individual', as used with re-
10	spect to a covert test of a transportation secu-
11	rity system, means any individual that—
12	"(i) the individual conducting the test
13	determines needs to know his or her status
14	as an individual conducting a test under
15	paragraph $(2)(B)$; or
16	"(ii) the cover team monitoring the
17	test under paragraph $(3)(B)(i)$ determines
18	needs to know the identity of an individual
19	conducting the test.
20	"(B) COVERED EMPLOYEE.—The term
21	'covered employee' means any individual who
22	receives notice of a covert test before the com-
23	pletion of a test under paragraph $(2)(A)$.

24 "(C) Covert test.—

1	"(i) IN GENERAL.—The term 'covert
2	test' means an exercise or activity con-
3	ducted by a covert testing office, the In-
4	spector General of the Department of
5	Homeland Security, or the Government Ac-
6	countability Office to intentionally test,
7	compromise, or circumvent transportation
8	security systems to identify vulnerabilities
9	in such systems.
10	"(ii) LIMITATION.—Notwithstanding
11	clause (i), the term 'covert test' does not
12	mean an exercise or activity by an em-
13	ployee or contractor of the Transportation
14	Security Administration to test or assess
15	compliance with regulations under title 49,
16	Code of Federal Regulations.
17	"(D) COVERT TESTING OFFICE.—The term
18	'covert testing office' means any office of the
19	Transportation Security Administration des-
20	ignated by the Assistant Secretary of Homeland
21	Security (Transportation Security Administra-
22	tion) to conduct covert tests of transportation
23	security systems.
24	"(E) Employee of a covert testing
25	OFFICE.—The term 'employee of a covert test-

ing office' means an individual who is an employee of a covert testing office or a contractor or an employee of a contractor of a covert testing office.".
