A BILL

To amend the Marine Mammal Protection Act of 1972 to prohibit the taking, importation, and exportation of Orcas and Orca products for public display, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Orca Responsibility
5 and Care Advancement Act of 2017”.

1 **SEC. 2. PROHIBITION ON TAKING, IMPORTATION, AND EX-**
2 **PORTATION OF ORCAS AND ORCA PRODUCTS**
3 **FOR PUBLIC DISPLAY.**

4 (a) PROHIBITION ON PERMITS FOR TAKING OR IM-
5 PORTATION.—Section 104(a) of the Marine Mammal Pro-
6 tection Act of 1972 (16 U.S.C. 1374(a)) is amended to
7 read as follows:

8 “(a)(1) Except as provided in paragraph (2), the Sec-
9 retary may issue permits which authorize the taking or
10 importation of any marine mammal.

11 “(2) Notwithstanding any other provision of law, no
12 permit may be issued by the Secretary that authorizes the
13 taking or importation of any marine mammal of the spe-
14 cies *Orcinus orca*, or any marine mammal product that
15 consists, or is composed in whole or in part, of such spe-
16 cies, for the purpose of public display.

17 “(3) Permits for the incidental taking of marine
18 mammals in the course of commercial fishing operations
19 may only be issued as specifically provided for in section
20 101(a)(5) or 306, or subsection (h) of this section.”.

21 (b) PROHIBITION ON EXPORTATION FOR PUBLIC
22 DISPLAY.—Section 102 of the Marine Mammal Protection
23 Act of 1972 (16 U.S.C. 1372(a)) is amended by adding
24 at the end the following new subsections:

25 “(g) Notwithstanding any other provision of law, it
26 is unlawful to export any marine mammal product that

1 consists, or is composed in whole or in part, of the species
2 *Orcinus orca*.

3 “(h)(1) Notwithstanding any other provision of law,
4 it is unlawful to export any marine mammal of the species
5 *Orcinus orca*—

6 “(A) for a purpose other than to transport such
7 marine mammal to a marine mammal sanctuary;
8 and

9 “(B) without a determination by the Secretary
10 that the transportation to such sanctuary is in the
11 best interest of the individual marine mammal.

12 “(2) In this subsection, the term ‘sanctuary’ means
13 a place of refuge where marine mammals—

14 “(A) live in a setting as close as possible to
15 their natural environment;

16 “(B) are prioritized individually with respect to
17 well-being and autonomy; and

18 “(C) are not used for profit or bred.”.

19 **SEC. 3. PROHIBITION ON BREEDING OF ORCAS.**

20 The Animal Welfare Act is amended by inserting
21 after section 26 (7 U.S.C. 2156) the following new section:

22 **“SEC. 26A. BREEDING OF ORCAS.**

23 “It shall be unlawful for any person to artificially in-
24 seminate or breed a marine mammal of the species

- 1 Orcinus orca for purposes of using the progeny of such
- 2 species for public display.”.
