Mr. TAKANO (for himself, Mr. VAN HOLLEN, Mr. DELANEY, Ms. TSONGAS, and Mr. TED LIEU of California) introduced the following bill; which was referred to the Committee on Armed Services

## A BILL

To require a demonstration program on the accession as Air Force officers of candidates with auditory impairments.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Keith Nolan Air Force  
5       Deaf Demonstration Act of 2015”.

6       **SEC. 2. DEMONSTRATION PROGRAM ON ACCESSION OF**  
7                   **CANDIDATES WITH AUDITORY IMPAIRMENTS**  
8                   **AS AIR FORCE OFFICERS.**

9       (a) DEMONSTRATION PROGRAM REQUIRED.—Begin-  
10      ning not later than 90 days after the date of the enact-

1 ment of this Act, the Secretary of the Air Force shall carry  
2 out a demonstration program to assess the feasibility and  
3 advisability of permitting individuals with auditory impair-  
4 ments (including deafness) to access as officers of the Air  
5 Force.

6 (b) CANDIDATES.—

7 (1) NUMBER OF CANDIDATES.—The total num-  
8 ber of individuals with auditory impairments who  
9 may participate in the demonstration program shall  
10 be not fewer than 15 individuals or more than 20 in-  
11 dividuals.

12 (2) MIX AND RANGE OF AUDITORY IMPAIR-  
13 MENTS.—The individuals who participate in the  
14 demonstration program shall include individuals who  
15 are deaf and individuals who have a range of other  
16 auditory impairments.

17 (3) QUALIFICATION FOR ACCESSION.—Any indi-  
18 vidual who is chosen to participate in the demonstra-  
19 tion program shall meet all essential qualifications  
20 for accession as an officer in the Air Force, other  
21 than those related to having an auditory impair-  
22 ment.

23 (c) SELECTION OF PARTICIPANTS.—

24 (1) IN GENERAL.—The Secretary of the Air  
25 Force shall—

1                         (A) publicize the demonstration program  
2                         nationally, including to individuals who have  
3                         auditory impairments and would be otherwise  
4                         qualified for officer training;

5                         (B) create a process whereby interested in-  
6                         dividuals can apply for the demonstration pro-  
7                         gram; and

8                         (C) select the participants for the dem-  
9                         onstration program, from among the pool of ap-  
10                         plicants, based on the criteria in subsection (b).

11                         (2) NO PRIOR SERVICE AS AIR FORCE OFFI-  
12                         CERS.—Participants selected for the demonstration  
13                         program shall be individuals who have not previously  
14                         served as officers in the Air Force.

15                         (d) BASIC OFFICER TRAINING.—

16                         (1) IN GENERAL.—The participants in the dem-  
17                         onstration program shall undergo, at the election of  
18                         the Secretary of the Air Force, the Basic Officer  
19                         Training course or the Commissioned Officer Train-  
20                         ing course at Maxwell Air Force Base, Alabama.

21                         (2) NUMBER OF PARTICIPANTS.—Once individ-  
22                         uals begin participating in the demonstration pro-  
23                         gram, each Basic Officer Training course or Com-  
24                         missioned Officer Training course at Maxwell Air  
25                         Force Base, Alabama, shall include not fewer than

1       4, or more than 6, participants in the demonstration  
2       program until all participants have completed such  
3       training.

4                     (3) AUXILIARY AIDS AND SERVICES.—The Sec-  
5       retary of Defense shall ensure that participants in  
6       the demonstration program have the necessary auxil-  
7       iliary aids and services (as that term is defined in sec-  
8       tion 4 of the Americans With Disabilities Act of  
9       1990 (42 U.S.C. 12103)) in order to fully partici-  
10      pate in the demonstration program.

11                     (e) COORDINATION.—

12                     (1) SPECIAL ADVISOR.—The Secretary of the  
13       Air Force shall designate a special advisor to the  
14       demonstration program to act as a resource for par-  
15       ticipants in the demonstration program, as well as a  
16       liaison between participants in the demonstration  
17       program and those providing the officer training.

18                     (2) QUALIFICATIONS.—The special advisor shall  
19       be a member of the Armed Forces on active duty—

20                         (A) who—

21                             (i) if a commissioned officer, shall be  
22       in grade O–3 or higher; or

23                             (ii) if an enlisted member, shall be in  
24       grade E–5 or higher; and

1                             (B) who is knowledgeable about issues in-  
 2                             volving, and accommodations for, individuals  
 3                             with auditory impairments (including deafness).

4                             (3) RESPONSIBILITIES.—The special advisor  
 5                             shall be responsible for facilitating the officer train-  
 6                             ing for participants in the demonstration program,  
 7                             intervening and resolving issues and accommo-  
 8                             dations during the training, and such other duties as  
 9                             the Secretary of the Air Force may assign to facili-  
 10                          tate the success of the demonstration program and  
 11                          participants.

12                         (f) REPORT.—Not later than two years after the date  
 13                         of the enactment of this Act, the Secretary of the Air  
 14                         Force shall submit to the appropriate committees of Con-  
 15                         gress a report on the demonstration program. The report  
 16                         shall include the following:

17                         (1) A description of the demonstration program  
 18                         and the participants in the demonstration program.

19                         (2) The outcome of the demonstration program,  
 20                         including—

21                         (A) the number of participants in the dem-  
 22                         onstration program that successfully completed  
 23                         the Basic Officer Training course or the Com-  
 24                         missioned Officer Training course;

1                             (B) the number of participants in the dem-  
2                             onstration program that were recommended for  
3                             continued military service;

4                             (C) the issues that were encountered dur-  
5                             ing the program; and

6                             (D) such recommendation for modifications  
7                             to the demonstration program as the Secretary  
8                             considers appropriate to increase further inclu-  
9                             sion of individuals with auditory disabilities  
10                          serving as officers in the Air Force or other  
11                          Armed Forces.

12                         (3) Such recommendations for legislative or ad-  
13                         ministrative action as the Secretary considers appro-  
14                         priate in light of the demonstration program.

15                         (g) APPROPRIATE COMMITTEES OF CONGRESS DE-  
16                         FINED.—In this section, the term “appropriate commit-  
17                         tees of Congress” means—

18                         (1) the Committee on Armed Services, the  
19                         Committee on Health, Education, Labor, and Pen-  
20                         sions, and the Committee on Appropriations of the  
21                         Senate; and

22                         (2) the Committee on Armed Services and the  
23                         Committee on Appropriations of the House of Rep-  
24                         resentatives.
