1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Pre-Disaster Mitiga-3 tion Act of 2009".

4 SEC. 2. PRE-DISASTER HAZARD MITIGATION.

5 (a) ALLOCATION OF FUNDS.—Section 203(f) of the
6 Robert T. Stafford Disaster Relief and Emergency Assist7 ance Act (42 U.S.C. 5133(f)) is amended to read as fol8 lows:

9 "(f) Allocation of Funds.—

"(1) IN GENERAL.—The President shall award
financial assistance under this section on a competitive basis and in accordance with the criteria in subsection (g).

"(2) MINIMUM AND MAXIMUM AMOUNTS.—In
providing financial assistance under this section, the
President shall ensure that the amount of financial
assistance made available to a State (including
amounts made available to local governments of the
State) for a fiscal year—

- 20 "(A) is not less than the lesser of—
- 21 "(i) \$575,000; or

"(ii) the amount that is equal to one
percent of the total funds appropriated to
carry out this section for the fiscal year;
and

"(B) does not exceed the amount that is
 equal to 15 percent of the total funds appro priated to carry out this section for the fiscal
 year.".

5 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
6 203(m) of such Act (42 U.S.C. 5133(m)) is amended to
7 read as follows:

8 "(m) AUTHORIZATION OF APPROPRIATIONS.—There 9 is authorized to be appropriated to carry out this section 10 \$250,000,000 for each of fiscal years 2010, 2011, and 11 2012.".

12 (c) REFERENCES.—Section 203 of such Act (42
13 U.S.C. 5133) is amended—
