## **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Military Surviving5 Spouses Equity Act".

4 (b) PROHIBITION ON RETROACTIVE BENEFITS.—No
5 benefits may be paid to any person for any period before
6 the effective date provided under subsection (f) by reason
7 of the amendments made by subsection (a).

(c) PROHIBITION ON RECOUPMENT OF CERTAIN 8 9 AMOUNTS PREVIOUSLY REFUNDED TO SBP RECIPI-ENTS.—A surviving spouse who is or has been in receipt 10 of an annuity under the Survivor Benefit Plan under sub-11 12 chapter II of chapter 73 of title 10, United States Code, 13 that is in effect before the effective date provided under 14 subsection (f) and that is adjusted by reason of the 15 amendments made by subsection (a) and who has received a refund of retired pay under section 1450(e) of title 10, 16 United States Code, shall not be required to repay such 17 18 refund to the United States.

19 (d) REPEAL OF AUTHORITY FOR OPTIONAL ANNUITY
20 FOR DEPENDENT CHILDREN.—Section 1448(d)(2) of
21 such title is amended—

(1) by striking "DEPENDENT CHILDREN.—"
and all that follows through "In the case of a member described in paragraph (1)," and inserting "DE-

PENDENT CHILDREN.—In the case of a member de scribed in paragraph (1),"; and

3 (2) by striking subparagraph (B).

4 (e) RESTORATION OF ELIGIBILITY FOR PREVIOUSLY ELIGIBLE SPOUSES.—The Secretary of the military de-5 partment concerned shall restore annuity eligibility to any 6 7 eligible surviving spouse who, in consultation with the Sec-8 retary, previously elected to transfer payment of such an-9 nuity to a surviving child or children under the provisions 10 of section 1448(d)(2)(B) of title 10, United States Code, as in effect on the day before the effective date provided 11 12 under subsection (f). Such eligibility shall be restored 13 whether or not payment to such child or children subsequently was terminated due to loss of dependent status 14 15 or death. For the purposes of this subsection, an eligible spouse includes a spouse who was previously eligible for 16 17 payment of such annuity and is not remarried, or remarried after having attained age 55, or whose second or sub-18 sequent marriage has been terminated by death, divorce 19 20 or annulment.

(f) EFFECTIVE DATE.—This section and the amendments made by this section shall take effect on the later
of—
