Mr. GRIMM (for himself, Mr. PASCRELL, Mr. REICHERT, and Mr. PIERLUISI) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To encourage, enhance, and integrate Blue Alert plans throughout the United States in order to disseminate information when a law enforcement officer is seriously injured or killed in the line of duty.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Blue Alert
5 Act of 2013”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) COORDINATOR.—The term “Coordinator”
2 means the Blue Alert Coordinator of the Depart-
3 ment of Justice designated under section 4(a).

4 (2) BLUE ALERT.—The term “Blue Alert”
5 means information relating to the serious injury or
6 death of a law enforcement officer in the line of duty
7 sent through the network.

8 (3) BLUE ALERT PLAN.—The term “Blue Alert
9 plan” means the plan of a State, unit of local gov-
10 ernment, or Federal agency participating in the net-
11 work for the dissemination of information received
12 as a Blue Alert.

13 (4) LAW ENFORCEMENT OFFICER.—The term
14 “law enforcement officer” shall have the same mean-
15 ing as in section 1204 of the Omnibus Crime Con-
16 trol and Safe Streets Act of 1968 (42 U.S.C.
17 3796b(6)).

18 (5) NETWORK.—The term “network” means
19 the Blue Alert communications network established
20 by the Attorney General under section 3.

21 (6) STATE.—The term “State” means each of
22 the 50 States, the District of Columbia, Puerto Rico,
23 the United States Virgin Islands, Guam, American
24 Samoa, and the Commonwealth of the Northern
25 Mariana Islands.

1 **SEC. 3. BLUE ALERT COMMUNICATIONS NETWORK.**

2 The Attorney General shall establish a national Blue
3 Alert communications network within the Department of
4 Justice to issue Blue Alerts through the initiation, facilita-
5 tion, and promotion of Blue Alert plans, in coordination
6 with States, units of local government, law enforcement
7 agencies, and other appropriate entities.

8 **SEC. 4. BLUE ALERT COORDINATOR; GUIDELINES.**

9 (a) COORDINATION WITHIN DEPARTMENT OF JUS-
10 TICE.—The Attorney General shall assign an existing offi-
11 cer of the Department of Justice to act as the national
12 coordinator of the Blue Alert communications network.

13 (b) DUTIES OF THE COORDINATOR.—The Coordi-
14 nator shall—

15 (1) provide assistance to States and units of
16 local government that are using Blue Alert plans;

17 (2) establish voluntary guidelines for States and
18 units of local government to use in developing Blue
19 Alert plans that will promote compatible and inte-
20 grated Blue Alert plans throughout the United
21 States, including—

22 (A) a list of the resources necessary to es-
23 tablish a Blue Alert plan;

24 (B) criteria for evaluating whether a situa-
25 tion warrants issuing a Blue Alert;

(C) guidelines to protect the privacy, dignity, independence, and autonomy of any law enforcement officer who may be the subject of a Blue Alert and the family of the law enforcement officer;

(D) guidelines that a Blue Alert should only be issued with respect to a law enforcement officer if—

11 (I) confirms—

12 (aa) the death or serious in-
13 jury of the law enforcement offi-
14 cer; or

15 (bb) the attack on the law
16 enforcement officer and that
17 there is an indication of the
18 death or serious injury of the of-
19 ficer; or

(II) concludes that the law enforcement officer is missing in the line of duty;

(iii) the suspect involved has not been apprehended; and

(iv) there is sufficient descriptive information of the suspect involved and any relevant vehicle and tag numbers;

(E) guidelines—

(i) that information relating to a law enforcement officer who is seriously injured or killed in the line of duty should be provided to the National Crime Information Center database operated by the Federal Bureau of Investigation under section 534 of title 28, United States Code, and any relevant crime information repository of the State involved;

(ii) that a Blue Alert should, to the maximum extent practicable (as determined by the Coordinator in consultation with law enforcement agencies of States and units of local governments), be limited to the geographic areas most likely to facilitate the apprehension of the suspect involved or which the suspect could reasonably reach, which should not be limited to State lines;

(iii) for law enforcement agencies of

States or units of local government to develop plans to communicate information to neighboring States to provide for seamless communication of a Blue Alert; and

(iv) providing that a Blue Alert should be suspended when the suspect involved is apprehended or when the law enforcement agency involved determines that

the Blue Alert is no longer effective; and
(F) guidelines for—

(i) the issuance of Blue Alerts

through the network; and

(ii) the extent of the dissemination of

alerts issued through the network;

(3) develop protocols for efforts to apprehend

suspects that address activities during the period be-

ginning at the time of the initial notification of a

law enforcement agency that a suspect has not been

apprehended and ending at the time of apprehension

of a suspect or when the law enforcement agency in-

volved determines that the Blue Alert is no longer

effective, including protocols regulating—

(A) the use of public safety communica-

(B) command center operations; and

(C) incident review, evaluation, debriefing,

and public information procedures;

(4) work with States to ensure appropriate re-

gional coordination of various elements of the net-

work;

(5) establish an advisory group to assist States,

units of local government, law enforcement agencies,

and other entities involved in the network with initi-

ating, facilitating, and promoting Blue Alert plans,

which shall include—

(A) to the

(A) to the maximum extent practicable,

representation from the various geographic re-

gions of the United States; and

(B) members who are—

(i) representatives of a law enforce-

ment organization representing rank-and-

file officers;

(ii) representatives of other law en-

forcement agencies and public safety com-

munications;

(iii) broadcasters, first responders,

dispatchers, and radio station personnel;

and

(iv) representatives of any other individuals or organizations that the Coordinator determines are necessary to the success of the network;

(6) act as the nationwide point of contact for—

(A) the development of the network; and

(B) regional coordination of Blue Alerts

through the network; and

(7) determine—

(A) what procedures and practices are in use for notifying law enforcement and the public when a law enforcement officer is killed or seriously injured in the line of duty; and

(B) which of the procedures and practices are effective and that do not require the expenditure of additional resources to implement.

(c) LIMITATIONS.—

(1) VOLUNTARY PARTICIPATION.—The guidelines established under subsection (b)(2), protocols developed under subsection (b)(3), and other programs established under subsection (b), shall not be mandatory.

(2) DISSEMINATION OF INFORMATION.—The guidelines established under subsection (b)(2) shall, to the maximum extent practicable (as determined

1 by the Coordinator in consultation with law enforce-
2 ment agencies of States and units of local govern-
3 ment), provide that appropriate information relating
4 to a Blue Alert is disseminated to the appropriate
5 officials of law enforcement agencies, public health
6 agencies, and other agencies.

7 (3) PRIVACY AND CIVIL LIBERTIES PROTEC-
8 TIONS.—The guidelines established under subsection
9 (b) shall—

10 (A) provide mechanisms that ensure that
11 Blue Alerts comply with all applicable Federal,
12 State, and local privacy laws and regulations;
13 and

14 (B) include standards that specifically pro-
15 vide for the protection of the civil liberties, in-
16 cluding the privacy, of law enforcement officers
17 who are seriously injured or killed in the line of
18 duty and the families of the officers.

19 (d) COOPERATION WITH OTHER AGENCIES.—The
20 Coordinator shall cooperate with the Secretary of Home-
21 land Security, the Secretary of Transportation, the Chair-
22 man of the Federal Communications Commission, and ap-
23 propriate offices of the Department of Justice in carrying
24 out activities under this Act.

1 (e) RESTRICTIONS ON COORDINATOR.—The Coordin-
2 ator may not—

- 3 (1) perform any official travel for the sole pur-
4 pose of carrying out the duties of the Coordinator;
5 (2) lobby any officer of a State regarding the
6 funding or implementation of a Blue Alert plan; or
7 (3) host a conference focused solely on the Blue
8 Alert program that requires the expenditure of Fed-
9 eral funds.

10 (f) REPORTS.—Not later than 1 year after the date
11 of enactment of this Act, and annually thereafter, the Co-
12 ordinator shall submit to Congress a report on the activi-
13 ties of the Coordinator and the effectiveness and status
14 of the Blue Alert plans that are in effect or being devel-
15 oped.
