1 Be it enacted by the Senate and House of Representa-

1	SECTION 1. EXPANSION OF VOLUNTEER REPRESENTATION
2	AND BENCHMARK REPORTS.
3	(a) Expansion of Volunteer Representa-
4	TION.—Section 8(b)(1)(B) of the Small Business Act (15
5	U.S.C. 637(b)(1)(B)) is amended—
6	(1) by inserting "(i)" after "(B)"; and
7	(2) by adding at the end the following:
8	"(ii) The Administrator shall ensure that
9	SCORE, established under this subparagraph, car-
10	ries out a plan to increase the proportion of mentors
11	who are from socially or economically disadvantaged
12	backgrounds and, on an annual basis, reports to the
13	Administrator on the implementation of this sub-
14	paragraph.".
15	(b) BENCHMARK REPORTS.—Section 8(b)(1)(B) of
16	the Small Business Act (15 U.S.C. 637(b)(1)(B)), as
17	amended, is further amended by adding at the end the
18	following:
19	"(iii) The Administrator shall ensure that
20	SCORE, established under this subparagraph, estab-
21	lishes benchmarks for use in evaluating the perform-
22	ance of its activities and of its volunteers. The
23	benchmarks shall include benchmarks relating to the
24	demographic characteristics and the geographic
25	characteristics of persons assisted by SCORE,
26	benchmarks related to the hours spent mentoring by

volunteers, and benchmarks relating to the perform ance of the persons assisted by SCORE. SCORE
 shall report, on an annual basis, to the Adminis trator the extent to which the benchmarks estab lished under this clause are being attained.".

6 SEC. 2. MENTORING AND NETWORKING.

7 Section 8(b)(1)(B) of the Small Business Act (15
8 U.S.C. 637(b)(1)(B)), as amended, is further amended by
9 adding at the end the following:

10 "(iv) The Administrator shall ensure that 11 SCORE, established under this subparagraph, estab-12 lishes a mentoring program for small business concerns that provides one-on-one advice to small busi-13 14 ness concerns from qualified counselors. For pur-15 poses of this clause, qualified counselors are coun-16 selors with at least 10 years experience in the indus-17 try sector or area of responsibility of the small busi-18 ness concern seeking advice.

"(v) The Administrator shall carry out a networking program through SCORE, established
under this subparagraph, that provides small business concerns with the opportunity to make business
contacts in their industry or geographic region.".

2	(a) NAME CHANGE.—The Small Business Act is

10	Corps of Retired Executives" and inserting
11	"SCORE".
12	(3) In section 20 (15 U.S.C. 631 note)—
13	(A) in subsection $(d)(1)(E)$, by striking
14	"the Service Corps of Retired Executives pro-
15	gram" and inserting "SCORE"; and
16	(B) in subsection $(e)(1)(E)$, by striking
17	"the Service Corps of Retired Executives pro-
18	gram" and inserting "SCORE".
19	(4) In section $33(b)(2)$ (15 U.S.C. $657c(b)(2)$),
20	by striking "Service Corps of Retired Executives"
21	and inserting "SCORE".
22	(b) Elimination of ACE.—Section 8(b)(1)(B) of
23	the Small Business Act $(15 \text{ U.S.C. } 637(b)(1)(B))$, as
24	amended, is further amended by striking "and an Active
25	Corps of Executive (ACE)".

1 SEC. 4. AUTHORIZATION OF APPROPRIATIONS.

2 Section 20 of the Small Business Act (15 U.S.C. 631
3 note) is amended by inserting the following new subsection
4 after subsection (e):

5 "(f) AUTHORIZATION OF APPROPRIATIONS FOR
6 SCORE.—There is authorized to be appropriated
7 \$7,000,000 for SCORE under section 8(b)(1) for each of
8 the fiscal years 2010 and 2011.".
