A BILL

To amend the Omnibus Public Land Management Act of
2009 to make the Reclamation Water Settlements Fund
permanent.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Indian Water Rights*
5 *Settlement Extension Act”.*

6 **SEC. 2. RECLAMATION WATER SETTLEMENTS FUND.**

7 *Section 10501 of the Omnibus Public Land Manage-*
8 *ment Act of 2009 (43 U.S.C. 407) is amended—*

9 *(1) in subsection (b)(1), by inserting “and for*
10 *fiscal year 2031 and each fiscal year thereafter” after*
11 *“For each of fiscal years 2020 through 2029”;*

12 *(2) in subsection (c)—*

13 *(A) in paragraph (1)(A), by striking “for*
14 *each of fiscal years 2020 through 2034” and in-*
15 *serting “for fiscal year 2020 and each fiscal year*
16 *thereafter”; and*

17 *(B) in paragraph (3)(C), by striking “for*
18 *any authorized use” and all that follows through*
19 *the period at the end and inserting “for any use*
20 *authorized under paragraph (2).”;* and

21 *(3) by striking subsection (f).*
