## A BILL

To authorize the establishment of an Asia-Pacific Defense Commission to enhance defense cooperation between the United States and allies in the Asia-Pacific region, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Asia-Pacific Defense  
5 Commission Act”.

1   **SEC. 2. FINDINGS.**

2       Congress finds the following:

3               (1) The United States has worked cooperatively  
4       with its allies and partners in the Asia-Pacific region  
5       for decades on issues of mutual concern having re-  
6       gional and global strategic and economic importance,  
7       including—

8                       (A) deterring and confronting external ag-  
9       gression against allies and partners;

10                      (B) ensuring the free flow of energy and  
11       commerce, and freedom of navigation in inter-  
12       national waters;

13                      (C) dismantling terrorist networks that  
14       threaten the safety of the region;

15                      (D) preventing the development, use, and  
16       proliferation of weapons of mass destruction;

17                      (E) adapting to climate change and severe  
18       weather events, including cooperation on hu-  
19       manitarian assistance and disaster response;  
20       and

21                      (F) promoting respect for the international  
22       liberal order based on commonly respected  
23       norms and values.

24                      (2) The close security relationships between the  
25       United States and its five treaty allies in the Asia-  
26       Pacific region—Australia, Japan, the Philippines,

1 South Korea and Thailand—as well as the security  
2 relationships between the United States and its non-  
3 alliance security partners in the region remain vital  
4 to the United States national interest and a corner-  
5 stone of regional stability.

6 (3) The United States opposes North Korea's  
7 illegal and reckless pursuit of nuclear weapons.

8 (4) Countering North Korea's destabilizing ac-  
9 tivities in the region by diplomatic, economic, and  
10 defensive means is a top national security issue for  
11 the United States as the threat posed by North  
12 Korea endangers United States allies, threatens to  
13 destabilize the Asia-Pacific region, and if unchecked,  
14 poses a grave nuclear proliferation challenge to the  
15 world.

16 **SEC. 3. ESTABLISHMENT OF ASIA-PACIFIC DEFENSE COM-**  
17 **MISSION.**

18 (a) **STATEMENT OF POLICY.—**

19 (1) **IN GENERAL.**—It is the policy of the United  
20 States to continue to maintain a strong military pos-  
21 ture in the Asia-Pacific region in order to reassure  
22 United States allies, deter aggression, and respond  
23 swiftly to crises.

24 (2) **ENHANCED MILITARY TRAINING AND EXER-**  
25 **CISES.**—The Secretary of Defense, in consultation

1       with the Secretary of State, shall seek opportunities  
2       to enhance military training and exercises with  
3       United States allies in the Asia-Pacific region to  
4       deepen cooperation between the militaries of the  
5       United States and such allies, to expand operational  
6       capabilities, and to encourage respect for human  
7       rights and the rule of law.

8           (b) JOINT DEFENSE COMMISSION.—The President  
9       may establish a regional joint defense commission to be  
10      known as the Asia-Pacific Defense Commission. The pur-  
11      pose of the commission shall be to strengthen cooperation  
12      between the United States and its allies in the Asia-Pacific  
13      region to combat joint threats. The commission may un-  
14      dertake the following activities:

15                  (1) Strengthening counterterrorism operations  
16       and building capacity to track, investigate, and pros-  
17       ecute individuals engaged in terrorist activities.

18                  (2) Improving regional maritime security and  
19       capabilities to interdict illegal arms shipments.

20                  (3) Bolstering regional cybersecurity initiatives  
21       and protecting critical infrastructure.

22                  (4) Strengthening military preparedness.

23                  (5) Facilitating defense-related transfers, sub-  
24       ject to the requirements of the Arms Export Control  
25       Act (22 U.S.C. 2751 et seq.).

1                         (6) Facilitating efforts to enhance training, preparedness, and operations by allies to address North  
2                         Korean maritime weapons transfers.

3  
4                         (7) Coordinating intelligence collected by the intelligence services of the countries participating in  
5                         the commission, identify the most immediate threats  
6                         to inform the security services of such countries, and  
7                         create guidelines for the coordination of multilateral  
8                         direct action against shared threats.

9  
10                         (c) ASIA-PACIFIC REGION.—In this section, the term  
11                         “Asia-Pacific region” means the region corresponding to  
12                         the area of responsibility of the United States Pacific  
13                         Command, as defined by the Department of Defense unified command plan.

14  
15                         (d) SENSE OF CONGRESS.—It is the sense of Congress that the United States Navy should regularize freedom of navigation operations, in accordance with international law, in the Japanese-administered Senkaku Islands, in the South China Sea, and in regular ports of call at strategic ports in the Asia-Pacific region.
