A BILL

To reauthorize the Hydrographic Services Improvement Act
of 1998, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Hydrographic Services*
5 *Improvement Amendments Act”.*

6 **SEC. 2. REAUTHORIZATION OF HYDROGRAPHIC SERVICES**

7 **IMPROVEMENT ACT OF 1998.**

8 (a) *REAUTHORIZATIONS.—Section 306 of the Hydro-*
9 *graphic Services Improvement Act of 1998 (33 U.S.C. 892d)*

10 *is amended—*

11 (1) *by inserting before “There are authorized”*
12 *the following: “(a) IN GENERAL.—”;*

13 (2) *in subsection (a) (as designated by para-*
14 *graph (1))—*

15 (A) *in paragraph (1), by striking “sur-*
16 *veys—” and all that follows through the end of*
17 *the paragraph and inserting “surveys,*
18 *\$70,814,000 for each of fiscal years 2019 through*
19 *2023.”;*

20 (B) *in paragraph (2), by striking “vessels—*
21 *” and all that follows through the end of the*
22 *paragraph and inserting “vessels, \$25,000,000*
23 *for each of fiscal years 2019 through 2023.”;*

24 (C) *in paragraph (3), by striking “Admin-*
25 *istration—” and all that follows through the end*

1 *of the paragraph and inserting “Administration,*
2 *\$29,932,000 for each of fiscal years 2019 through*
3 *2023.”;*

4 (D) *in paragraph (4), by striking*
5 *“title—” and all that follows through the end of*
6 *the paragraph and inserting “title, \$26,800,000*
7 *for each of fiscal years 2019 through 2023.”; and*

8 (E) *in paragraph (5), by striking*
9 *“title—” and all that follows through the end of*
10 *the paragraph and inserting “title, \$30,564,000*
11 *for each of fiscal years 2019 through 2023.”; and*
12 (3) *by adding at the end the following new sub-*
13 *section:*

14 “(b) *ARCTIC PROGRAMS.*—*Of the amount authorized*
15 *by this section for each fiscal year—*

16 “(1) *\$10,000,000 is authorized for use to acquire*
17 *hydrographic data, provide hydrographic services,*
18 *conduct coastal change analyses necessary to ensure*
19 *safe navigation, and improve the management of*
20 *coastal change in the Arctic; and*

21 “(2) *\$2,000,000 is authorized for use to acquire*
22 *hydrographic data and provide hydrographic services*
23 *in the Arctic necessary to delineate the United States*
24 *extended Continental Shelf.”.*

1 (b) *LIMITATION ON ADMINISTRATIVE EXPENSES FOR*
2 *SURVEYS.*—Section 306 of such Act (33 U.S.C. 892d) is fur-
3 *ther amended by adding at the end the following:*

4 “(c) *LIMITATION ON ADMINISTRATIVE EXPENSES FOR*
5 *SURVEYS.*—Of amounts authorized by this section for each
6 *fiscal year for hydrographic surveys, not more than 5 per-*
7 *cent is authorized for administrative costs.”.*

8 **SEC. 3. GAO STUDY.**

9 *The Comptroller General of the United States shall, by*
10 *not later than 18 months after the date of enactment of this*
11 *Act—*

12 (1) *conduct a study comparing the unit costs of*
13 *hydrographic surveys conducted by the National Oce-*
14 *anic and Atmospheric Administration and the unit*
15 *costs of procuring performance of such surveys; and*
16 (2) *report to the Congress on the findings of such*
17 *study.*
