AN ACT

To reauthorize the Hydrographic Services Improvement Act of 1998, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Hydrographic Services
5 Improvement Amendments Act”.

6 **SEC. 2. REAUTHORIZATION OF HYDROGRAPHIC SERVICES**
7 **IMPROVEMENT ACT OF 1998.**

8 (a) REAUTHORIZATIONS.—Section 306 of the Hydro-
9 graphic Services Improvement Act of 1998 (33 U.S.C.
10 892d) is amended—

1 (1) by inserting before “There are authorized”
2 the following: “(a) IN GENERAL.—”;

3 (2) in subsection (a) (as designated by para-
4 graph (1))—

5 (A) in paragraph (1), by striking “sur-
6 veys—” and all that follows through the end of
7 the paragraph and inserting “surveys,
8 \$70,814,000 for each of fiscal years 2019
9 through 2023.”;

10 (B) in paragraph (2), by striking “ves-
11 sels—” and all that follows through the end of
12 the paragraph and inserting “vessels,
13 \$25,000,000 for each of fiscal years 2019
14 through 2023.”;

15 (C) in paragraph (3), by striking “Admin-
16 istration—” and all that follows through the
17 end of the paragraph and inserting “Adminis-
18 tration, \$29,932,000 for each of fiscal years
19 2019 through 2023.”;

20 (D) in paragraph (4), by striking
21 “title—” and all that follows through the end
22 of the paragraph and inserting “title,
23 \$26,800,000 for each of fiscal years 2019
24 through 2023.”; and

1 (E) in paragraph (5), by striking
2 “title—” and all that follows through the end
3 of the paragraph and inserting “title,
4 \$30,564,000 for each of fiscal years 2019
5 through 2023.”; and

6 (3) by adding at the end the following new sub-
7 section:

8 “(b) ARCTIC PROGRAMS.—Of the amount authorized
9 by this section for each fiscal year—

10 “(1) \$10,000,000 is authorized for use to ac-
11 quire hydrographic data, provide hydrographic serv-
12 ices, conduct coastal change analyses necessary to
13 ensure safe navigation, and improve the manage-
14 ment of coastal change in the Arctic; and

15 “(2) \$2,000,000 is authorized for use to ac-
16 quire hydrographic data and provide hydrographic
17 services in the Arctic necessary to delineate the
18 United States extended Continental Shelf.”.

19 (b) LIMITATION ON ADMINISTRATIVE EXPENSES FOR
20 SURVEYS.—Section 306 of such Act (33 U.S.C. 892d) is
21 further amended by adding at the end the following:

22 “(c) LIMITATION ON ADMINISTRATIVE EXPENSES
23 FOR SURVEYS.—Of amounts authorized by this section for
24 each fiscal year for hydrographic surveys, not more than
25 5 percent is authorized for administrative costs.”.

1 **SEC. 3. GAO STUDY.**

2 The Comptroller General of the United States shall,
3 by not later than 18 months after the date of enactment
4 of this Act—

5 (1) conduct a study comparing the unit costs of
6 hydrographic surveys conducted by the National
7 Oceanic and Atmospheric Administration and the
8 unit costs of procuring performance of such surveys;
9 and

10 (2) report to the Congress on the findings of
11 such study.
